I am a Retired City of Quincy Supt. Of Inspection. In that capacity, I reviewed plans and building construction for the Quincy Medical Group clinic and Surgery Center, as well as the Blessing College of Nursing, addition of the Radiation bunker, and the Blessing Cancer Center. I have volunteered weekly at Blessing since 2007, in spite of a Quadruple bypass, back surgeries, and kidney stones. My family and our community depends on this facility to care for us, not only for the "easy" outpatient care, but to maintain expensive surgical suites, fully equipped, with professionally prepared staff who will be there for us when the situation is not quick and easy. Quincy Medical Group's proposed surgery center would impact this negatively.

Our population and the 50 mile radius cannot support this duplication of services, and siphon from the same pool of professionals. My primary physician is at QMG, and my cardiothoracic surgeon is at Blessing Physician Services. Having a choice is key, but if duplication and dilution occurs, I may eventually be left with no options locally. So many towns have lost their hospitals. Blessing has been a good steward and received community support, as it gives community services.

Dear Ms. Avery:

My name is Chuck Johnson and I serve as Administrative Coordinator of Behavioral health Services at Blessing Hospital. I provided testimony at the IHFPRB Public Hearing the CON 18-042. I would like to take this opportunity to comment on the potential impact on Behavioral Health Services at Blessing Hospital from the proposed Quincy Medical Group CON to establish a cancer/surgical center. I must **oppose** this CON application, and urge the Review Board to **deny** it.

Blessing is a community not-for-profit with 41 licensed behavioral beds consisting of two adult units (with 10 and 16 beds each), and one child and adolescent unit (with 15 beds). The hospital has the only child and adolescent unit within a 100 mile radius and the only adult program within 80 miles in Illinois, Missouri and Iowa. There are no inpatient behavioral health adult or adolescent units in Northeast Missouri, and only one 10 bed adult unit in Southeast Iowa.

Over 50% of Blessing Behavioral Health admissions are referred by hospitals, mental health centers, and social service agencies outside of Adams County. While other hospitals in Hannibal, Missouri and Keokuk, Iowa closed their adult units, Blessing Hospital made a commitment to continue its inpatient and outpatient behavioral health programs.

Behavioral health admissions have increased from 1622 in 2010 to 2080 in 2018. Average daily census increased from 25.95 in 2010 to 34.12 in 2018. In other words, the need for this rare and precious resource is increasing.

Behavioral health programs are primarily utilized by an indigent and Medicaid population whose reimbursement cannot support its existence – not without the financial revenue from other hospital departments such as the Cancer and Surgical Centers. Blessing's commitment to indigent care is reflected in a 77% behavioral health public funding, including Medicaid and Medicare. Fifty-eight percent of behavioral health admissions are Medicaid, the Illinois per diem rate is \$433.45.

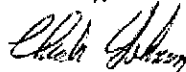
In addition to impacting behavioral health services the proposed CON would have the following negative impact on our community:

1. QMG proposal is a duplication of services. For the past 10 years Blessing and QMG have offered an outpatient surgery center on the QMG campus which Blessing owns and QMG manages. A second outpatient surgery center is not needed in our community.
2. Damage to the Safety Net and Community Benefit programs (providers who organize and deliver a significant level of health care and other related services to uninsured and service). Revenue from Blessing's outpatient surgery is used to support its not-for-profit mission of providing Safety Net services to the region. Opening a second surgery center would result in a loss to the current surgery center of nearly 12,000 cases and revenue of \$25-\$41 million which is needed by the community to keep Safety Net services operational. Additionally, as a non-profit healthcare provider, Blessing provides financial support to the education of healthcare professionals (Blessing-Rieman College of Nursing and Health Sciences, SIU Family Medicine Residency Program and charity care to those in need of healthcare, regardless of their ability to pay. The loss of outpatient surgery revenue threatens these and other community benefit programs.
3. Job loss, opening of a second surgery center would cost jobs. Blessing could lose approximately 400 jobs – 12 percent of the employee body - through the loss of a significant portion.
4. The need for community cooperation and health care planning. What is in this community's best interest is for Blessing and QMG to continue cooperation in joint planning and delivering key health care services. An example of this success is evident in the current joint partnership of the outpatient surgery center and with the Cancer Center. Blessing wants to continue work with QMG in improving the health of our community.

I urge you to consider the negative impact Quincy Medical Group's CON will have on the continued existence of Blessing Hospital's behavioral health, Safety Net and Community Benefit programs. I respectfully ask the Health Facilities and Services Review Board to deny CON application 18-042 to establish the Quincy Medical Group Surgery Center.

My name is Paul Warning and I am a therapist on the inpatient behavioral medicine service unit at Blessing Hospital. I have been with the organization for over 19 years. I am in opposition to the Quincy Medical Group Surgery Center for the following reasons:

1. The QMG proposal is a duplication of services. Blessing and QMG already offer an outpatient surgery center on the QMG campus. Blessing owns the service and QMG manages it. This has been a successful arrangement for more than 10 years now. Blessing would have no role in the proposed center. A second outpatient surgery center is not needed.
2. Much of the revenue Blessing generates from outpatient surgery is used to fulfill its not-for-profit mission of providing Safety Net services to the region. These Safety Net services include behavioral health care and trauma care. The Institute of Medicine defines the health care safety net as those providers who organize and deliver a significant level of health care and other related services to uninsured, Medicaid, and other vulnerable populations. The health care safety net is vital to the health of our communities and Blessing is the only provider in the region who offers these critical services. Insurance reimbursement does not provide adequate support for the delivery of inpatient behavioral medicine and trauma care. Opening a second surgery center would result in a loss to the current surgery center of nearly 12,000 cases and revenue of \$25-\$41 million. A significant portion of that revenue is needed by the community to keep Safety Net services operational

Additionally, as a non-profit healthcare provider, Blessing provides financial support to the education of healthcare professionals (*Blessing-Rieman College of Nursing & Health Sciences and the SIU Family Medicine Residency Program, an award-winning program that provides specialty training to new family physicians*); and charity care to those in need of healthcare, regardless of their ability to pay. While these are not Safety Net services, these are important community benefit investments, programs that cannot

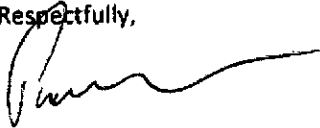
sustain themselves financially and rely on Blessing's support. The loss of outpatient surgery revenue threatens these and other community benefit programs.

Dear Ms. Avery:

I am Carol Espejo, M.D., a physician with the Blessing Health System for 13 years. I am writing to state my opposition to the CON 18-042 for the establishment of Quincy Medical Group Surgery Center.

As a physician with Blessing, I have the privilege of serving people in our community and outside communities from the tri-state area who are insured, underinsured, and uninsured. I count it a blessing to see patients without concerns about their ability to pay for my services as Blessing is a non-profit healthcare provider. Blessing has been providing excellent healthcare services to the community for many years while also offering services such as behavioral health care and trauma care. Not many communities of similar population can say the same thing. In fact, Blessing is the only provider in the region who offers these services. Because Blessing relies heavily on the revenue generated from the outpatient surgery to fund these programs, the establishment of a second surgery center, would jeopardize these services. We need the revenue from the outpatient surgery to sustain the needs of the Safety Net services. In addition, Blessing financially supports the education of healthcare professionals such as the Blessing Reiman College of Nursing and Health Sciences and the SIU Family Medicine Residency Program. As a physician, I can not overstate the importance of training nurses and physicians to fill these positions for the growing health care needs. Blessing needs all the revenues it can get, part of which comes from the surgery center, to sustain its support to these vital community programs.

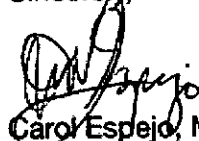
Blessing had been in collaboration with Quincy Medical Group to deliver health care services to our community for many years. The Cancer Center, outpatient surgery center, and the Blessing Hospital have been avenues for this collaboration, which, in my opinion, have worked for the benefit of the community. My name is Emily Hendrickson and I am the Associate Chief Nursing officer at Blessing Hospital, and have worked for the health system since 2000. I have been a member of the Adams County community since my birth in 1979. I also sit on the Adams County Ambulance Board. With each of these roles in mind, I respectfully, but strongly ask that the Health Facilities and Services Review Board oppose the CON application, 18-042.

In my current role, I work closely with the leadership, physician and staff of the Emergency Room. Our Emergency Department is a central hub of safety net resources for our entire region. As the building of this new surgery center will directly impact the revenue of our organization, these safety net services are at risk for lack of funding to provide for our region. We are a level II trauma center, and even receive Level I traumas because of our unique location within our region. We are a certified stroke and chest pain center. We have an entire regional STEMI network. We are currently training many emergency room and pediatric nurses to become certified Sexual Assault Nurse Examiners to support the Illinois Attorney General's program to provide a high level of care for victims of sexual abuse. Blessing will be a regional treatment center mandating call and overtime hours for these nurses to care for these patients.

In addition, our Emergency Room is a primary hub of mental health patient emergency visits. In 2012, Blessing Hospital built a 3 bed secure area within the Emergency Department to safely manage the needs of this population. Since that time, the ED mental health volume has increased from an average of 2.5 patients a day to almost 5 patients a day. Our inpatient mental health departments are frequently full, leaving these patients to overflow in the Emergency Room and often spend over 24 hours a day awaiting an inpatient bed. We are currently examining the need for future construction to allow for a larger secure area to meet the needs of mental health patients in the emergency room.

Each of the major safety net programs have little to no funding, yet we are required to have resources 24/7 to meet their needs. The loss of revenue cause by the Quincy Medical Group project will have a big impact on these necessary services.

As a community member & a previous Cardiac Cath Lab Director, duplication of cardiac services are going to increase costs to our community members. Patients will have no integrated electronic medical record. They will have 2 sets of cardiac cath diagnostic records, 2 sets of radiology films, and 2 sets of staff that risk different levels of competency and training. How is this the best thing for our patients when Healthcare services are supposed to put the patient at the center of the work we do?

As a member of the Adams County Ambulance Board, I come forward with concerns that no communication or collaboration has occurred with the Adams County Ambulance team as to what this could do to the call volume or any impact at all. With an offsite Cardiac Cath lab, what happens with emergencies that need to be transferred to the hospital? Long distance transfers for patients that need a higher level of care are currently declined or need to be rescheduled, often, because of the routine needs of the Ambulance community. Adding another opportunity for emergency response has unknown effects to our community.

As a nursing administrator at Blessing Hospital, we put our patients first in all that we do, in fact, it is our system's aim. The duplication of these services, as defined in CON 18-042, lacks this consistent message for the members of our regional healthcare community. It is with this knowledge that I ask you to oppose this certificate of need.

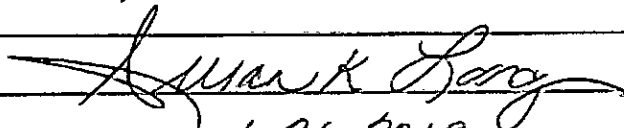

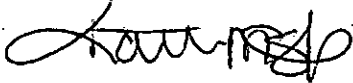

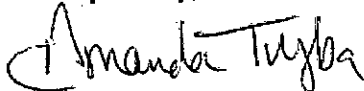
I serve as the Director of Inpatient Psychiatric Nursing Services at Blessing Hospital, with nursing oversight of the three inpatient behavioral health units. I have worked in behavioral health for over seven years as a Registered Nurse in rural communities.

Our inpatient behavioral health services are provided to patients of our community, and to surrounding areas where there is very limited access to mental health care. We are one of the few remaining inpatient facilities that serve our rural community population within a 100-mile radius, and one of the only facilities who offer inpatient treatment for children and adolescents between the University of Iowa in Iowa City, Iowa and Lincoln Prairie in Springfield, Illinois. Blessing Hospital recognizes the importance of the services we provide and has a devoted mission to our community and surrounding areas to continue to provide this necessary care while we try to overcome the national mental health crisis evident in our society today.

Nearly 45,000 Americans age 10 or older died by suicide in 2016. Suicide is the 10th leading cause of death and is one of just three leading causes that are on the rise according to the Centers for Disease Control and Prevention (CDC). These statistics are alarming, and it is tragic that families and communities across the country suffer from this loss daily because we, as a nation, are not doing our part to address the mental health crisis. It is evident that we cannot continue to allow closures of behavioral health facilities when our people drastically need our help. Our community needs the services that Blessing Inpatient Behavioral Health offers, this is evident by our estimated 90% occupancy of our adult inpatient units and continued rise in census on our adolescent unit. The patient population that Blessing Inpatient Behavioral Health serves will likely worsen significantly if we further constrain their resources to access of mental health care.

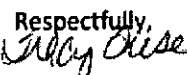
Dear Ms. Avery:

I have utilized services when needed at QMG but always prefer Blessing first as they are willing to work with patients and the prices are appropriate. This past year I was balance billed for a wellness visit that I kept because I had a great rapport with the physician at QMG and wanted to continue to see that provider but then received a bill for the balanced portion. It was nice that QMG did agree to work with Blessing and get this issue solved but it was only after several dissatisfied employees brought it to their attention.

This surgical site is clearly something that is not needed in this small rural community. I have concerns about the logistics of transporting someone that has an unexpected event happen during surgery when this facility is not very close to the actual hospital. It also concerns me that QMG hadn't contacted the ambulance service prior to submitting this as it makes me wonder if they really have thought this project through. I would much rather pick Blessing Hospital to have a cardiac catheter procedure done and have the hospital be on-site. These surgeries are high risk and I will add that as an employee here we often hear Code Blue in the cardiac catheter lab. I wouldn't want myself or any person that I cared about being miles from a hospital and having that kind of procedure.

I also have concerns for the community as well as the work family at Blessing. It is devastating to think that 400 employees may lose their jobs because of this proposed business idea. The current surgical center has been co-existing with Blessing and is successful. Additionally, as a non-profit healthcare provider, Blessing provides financial support to the education of healthcare professionals and charity care to those in need of healthcare, regardless of their ability to pay. While these are not Safety Net services, these are important community benefit investments, programs that cannot sustain themselves financially and rely on Blessing's support. 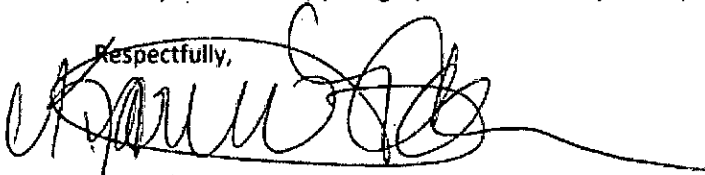

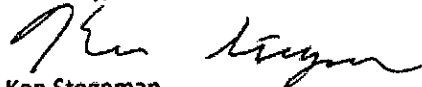

I can tell you that should Quincy Medical Group be successful in its efforts, Blessing will suffer greatly due to the loss of volume QMG Physicians currently represent.

More than 70% of the current procedures done in a given year at the Surgery Center are performed by Quincy Medical Group physicians. I'm sure you know very well that no business can sustain a loss of 70% of its business in an entire service line. I can't and don't speak for Blessing, but I would foresee the closure of Blessings Surgery Center should QMG be granted their request.

Undoubtedly, you are also aware that hospitals have many functions which they have out of necessity which are not financially viable. Inpatient Psychiatric Care is one service Blessing provides which we are not required to have. This service is hard to find across the state. Our Psych Unit has steady admissions from Rock Island, Peoria, Springfield, Northeast Missouri and all parts in between in addition to our local patients. This is a service that serves a highly indigent population who will be subject to traveling hours away from Quincy (away from their support networks) to receive care if Blessing should decide to abandon this mission in a cost saving measure. 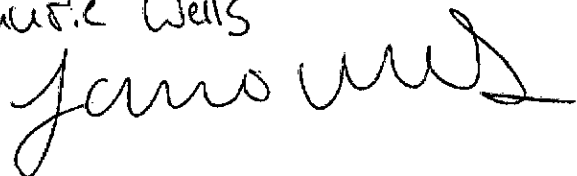

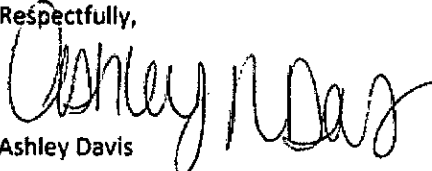
