The Board Staff is asking the Board Chair, acting on your behalf, to approve the discontinuation of a 16-bed Acute Mental Illness Category of Service at Carle Richland Memorial Hospital, 800 East Locust, Olney, Illinois (#E-025-18). The Applicants are Richland Memorial Hospital, Inc.dba Carle Richland Memorial Hospital and The Carle Foundation. The licensee and operating entity is Richland Memorial Hospital, Inc.dba Carle Richland Memorial Hospital. There is no cost to the discontinuation and the completion date is upon State Board approval.
