Board Members:

The State Board Staff is asking the Board Chair, acting on your behalf, to approve the discontinuation of the 6-station ESRD service at Memorial Medical Center. The Applicants (Memorial Medical Center and Memorial Health System) propose to discontinue the 6-station outpatient dialysis service located at Memorial Medical Center, 701 N. First Street, Springfield, Illinois (#E-027-18). There is no cost to the discontinuation and the completion date May 31, 2018. The 6-station ESRD service is being discontinued because of low utilization. Patients will be referred to other ESRD facilities in the area. The space will be used to provide acute dialysis services if necessary. Medical records will be maintained by Memorial Medical Center, per CMS and IDPH requirements. A Safety Net Impact Statement has been provided as required and impact letters

were sent to ESRD facilities within the 45-minute service area.

No public hearing was requested and no letters of support or opposition were received. The Applicants provided all of the information required by the State Board.
