STATE BOARD STAFF REPORT CHANGE OF OWNERSHIP EXEMPTION REQUEST

I. The Exemption Application

The Applicants (SRC Hospital Investments II, LLC, Pipeline – Weiss Memorial Hospital, LLC, VHS Acquisition Subsidiary Number 3, Inc. d/b/a Louis A. Weiss Memorial Hospital and Tenant Healthcare Corporation) propose a change of ownership of 100% interest in Louis A. Weiss Memorial Hospital a 236 acute care hospital. Louis A. Weiss Memorial Hospital is located at 4646 North Marine Drive, Chicago, Illinois (#E-050-18). The operating entity licensee will be Pipeline – Weiss Memorial Hospital, LLC and the owner of the site is Weiss Property Holdings, LLC. The expected completion date is November 1, 2018. This transaction is considered a purchase resulting in a change in the current licensee.

Under the terms of the Purchase Agreement, SRC Hospital Investment II, LLC will be acquiring VHS West Suburban Medical Center, VHS Westlake Hospital and Louis B. Weiss Memorial Hospital and certain assets used in connection with the operation of the Hospitals, from Tenet, VHS, and related entities, for Seventy Million Dollars (\$70,000,000), subject to adjustments for working capital and capital expenditures.

This change of ownership is before the State Board because the applicants are proposed a change in control of a health care facility.

II. Applicable Rules

The Illinois Health Facilities Planning Act defines a change of ownership as

"... a change in the person who has ownership or control of a health care facility's physical plant and capital assets. A change in ownership is indicated by the following transactions: sale, transfer, acquisition, lease, change of sponsorship or other means of transferring control."

The State Board's rule (77 IAC 1130.500 & 77 ILAC 1130.520) specifies the requirements necessary for a change of ownership exemption application to be filed with the State Board. The State Board may, by rule, delegate authority to the Chairman to grant permits or exemptions when applications meet all of the State Board's review criteria and are unopposed [20 ILCS 3960/5].


An exemption shall be approved when information required by the Board by rule is submitted [20 ILCS 3960/6].

<u>The State Board Staff Notes:</u> No support or opposition letters were submitted and there was no request for a public hearing. <u>All of the requirements</u> of the State Board have been met.
