**EXEMPTION APPLICANT(S):** Alexian Brothers-AHS Midwest Region Health Co. d/b/a AMITA Health, Adventist Midwest Health d/b/a Adventist LaGrange Memorial Hospital, and Adventist Health System Sunbelt Healthcare Corporation

### STATE BOARD STAFF REPORT DISCONTINUATION OF A CATEGORY OF SERVICE

#### I. The Exemption Application

The Applicants (Alexian Brothers-AHS Midwest Region Health Co. d/b/a AMITA Health, Adventist Midwest Health d/b/a Adventist LaGrange Memorial Hospital, and Adventist Health System Sunbelt Healthcare Corporation) propose the discontinuation of a 12-bed obstetric category of service. The operating entity/licensee and the owner of the site is Adventist Midwest Health. A Safety Net Impact Statement and Charity Care Information have been provided as required. Impact Letters were sent to hospitals within 10-miles of Adventist LaGrange Memorial Hospital that maintain obstetric services. The expected completion date is February 14, 2019.

The <u>exemption</u> is before the State Board because the transaction is a discontinuation of a category of service.

#### II. Background

Adventist LaGrange Memorial Hospital is a 196-bed hospital located in LaGrange, Illinois. The Inpatient obstetric days at the hospital have declined in recent years. The State Board's target occupancy for a 12-bed obstetric unit is 65%. The hospital reported in the Annual hospital profile over the past three years the pediatric unit has operated with an average daily census of three patients.

The Applicants have stated that the reason for the discontinuation of the obstetric category of service is low census. The obstetric service at the hospital was suspended on June 1, 2018 with a letter to the State Board and the Department of Public Health. The Applicants note that AMITA Medical Center – Hinsdale is within 10 minutes of Adventist LaGrange Memorial Hospital. The two hospitals have a common Medical Staff and management and during the 5-month period until this exemption application was filed the Applicants have referred obstetric patients to the Hinsdale facility. The Applicants will be consolidating obstetric services at the Hinsdale facility. The Hinsdale facility has a 37-bed obstetric unit that operated at 57.8% utilization in 2017. The State Board's target occupancy for an obstetric unit that has more than 26 beds is 78%.

The Applicants do not expect the discontinuation will have an adverse effect on access to care in the hospital's market area. There are 9 hospitals nearby that offer obstetric patient care.

#### II. Applicable Rules

The Illinois Health Facilities Planning Act (20 ILCS 3960/6) states the State Board shall establish by regulation the procedures and requirements regarding issuance of exemptions. An exemption shall be approved when information required by the Board by rule is submitted. Projects eligible for an exemption, rather than a permit, include, but are not limited to, change of ownership of a health care facility, <u>discontinuation of a category of service</u>, and discontinuation of a health care facility, other than a health care facility maintained by the State or any agency or department thereof or a nursing home maintained by a county.

The State Board's rule (77 IAC 1130.500 & 77 ILAC 1130.525) specifies the requirements necessary for a discontinuation of a category of service exemption application to be filed with the State Board. The State Board may, by rule, delegate authority to the Chairman to grant permits or exemptions when applications meet all of the State Board's review criteria and are unopposed [20 ILCS 3960/5].


