NOTICE OF REVIEW AND OPPORTUNITY FOR PUBLIC HEARING AND WRITTEN COMMENT

In accordance with the requirements of the Illinois Health Facilities Planning Act, revised notice is given of receipt to establish an Ambulatory Surgery Treatment Center (ASTC), in Chicago. Project #19-003, River North Center for Reproductive Health, Chicago. Applicants: River North Surgery Center, LLC, and Fertility Centers of Illinois, S.C. The applicants proposes to establish a limited-specialty ASTC containing four procedure rooms, in 18,258 GSF of leased space located at 361 West Chestnut Street, Chicago. Project cost: \$15,615,112.

The application was reevaluated for completeness on April 5, 2019, and was approved for expedited review with presentation to the Illinois Health Facilities and Services Review Board tentatively scheduled for the April 30, 2019 meeting.
