RE: Permit #E-028-20 – Change of Ownership Galesburg Cottage Hospital

Honorable Representative Swanson:

On April 7, 2020 Quorum Healthcare Corporation and their subsidiary Galesburg Cottage Hospital voluntarily filed for Chapter 11 bankruptcy protection. This restructuring will reduce Quorum's long-term debt by approximately \$500 million. On April 14, 2020 the State Board received an application for a change of ownership of Galesburg Cottage Hospital in response to that bankruptcy filing. A change of ownership of a health care facility requires State Board approval.

On May 5, 2020 the State Board received a second change of ownership for Galesburg Cottage Hospital. This application proposes the sale of Galesburg Cottage Hospital to SBJ Group Inc for approximately \$1.8 million. The legal notice is attached for your review.
