I am writing to express my support for The Rehabilitation Institute of Southern Illinois, LLC's Certificate of Need application to build a comprehensive inpatient rehabilitation hospital in St. Claire County, HSA-11. In my role as Chairman & Neurosurgeon- in- Chief, I am responsible for all clinical, research, and business related items for the Department of Neurological Surgery and Washington University School of Medicine.

Specifically for our patient population, considering the complexity of their care, we could see great benefit from a freestanding acute inpatient rehabilitation hospital in St. Claire County. As things currently stand, patients that live in Illinois face a number of barriers in receiving such care due as lack of close services for both the patients and their families. Crossing state lines to begin inpatient rehab is only one hurdle. There is also a lack of advanced technologies in acute rehab care, and limited locations turns into additional limitations relating to physician interaction and availability. If a facility is available closer to their homes overall therapy versus length of stay results balance out much more significantly. Having all available therapies in one location streamlines the process and allows for greater participation by the family members.

Currently, our faculty use The Rehabilitation Institute of St. Louis regularly for our extended patient care. The connection built between the medical staff at the rehab facility and our physicians continues to grow stronger on a regular basis due to availability and cohesive communication of the patient's care plan.

The Certificate of Need to the Rehabilitation Institute of Southern Illinois should be taken into consideration without reservation. Providing acute inpatient care to St. Claire County will only continue to strengthen the quality of care provided to our patients after they leave our facility. The location will provides significant opportunities for growth for both Washington University/Barnes-Jewish Hospital and the Rehabilitation Institutes.
