Dear Ms. Avery,

I am writing to express my support for The Rehabilitation Institute of Southern Illinois, LLC's Certificate of Need application to build a comprehensive inpatient rehabilitation hospital in St. Claire County, HSA-11. In my 20+ years as a vascular neurologist at Barnes-Jewish Hospital in St. Louis, I have diagnosed and treated countless patients who have suffered from a stroke or intracerebral hemorrhage.

Many of my patients in the acute care hospital setting would benefit from a freestanding acute inpatient rehabilitation hospital in St. Claire County, Illinois. Our neurology service cares for many of those patients who live in Southern Illinois but don't have easy access to an inpatient rehabilitation hospital such as The Rehabilitation Institute of St. Louis. As such those patients may not be getting the advantages of rehabilitation close to their home where it is convenient for their family to participate in their therapy and recovery. Since specialized inpatient rehabilitative care results in lower length of stay, improved cognitive and physical functionality, faster return to activities of daily living, and inclusion of family participation in rehabilitation, these patients need a talented team of rehabilitation-trained physicians, nurses and therapists who can provide this.

I strongly urge you to grant a Certificate of Need to The Rehabilitation Institute of Southern Illinois, LLC for an acute inpatient rehabilitation hospital in St. Claire County. I anticipate it will have an immediate positive impact on our hospital's length of stay, on caregiver education, and patient integration back into their own community.
