I am Chairman of the Department of Neurology at Washington University in St. Louis located at 660 South Euclid Avenue, St. Louis, Missouri 63110. The focus of my practice is Neurology. This letter is an addendum to my referral letter previously submitted on May 20, 2019. It contains referral documentation required per Ill. Admin. Code Section 1110.205(b)(3)(A)-(B). Over the past twelve months, I cared for a total of 658 Neurology patients who required comprehensive rehabilitation care from the 4 county HSA 11 area. Attached to this addendum is a list of zip codes for the 658 patients who have received care.

Based on my historical referrals, I would anticipate referring 300 patients each of the next two years to The Rehabilitation Institute of Southern Illinois Hospital as proposed by the applicant, if approved.
