Good afternoon:

Attached are two requests for permit renewal for the above mentioned projects, and the State Board Staff Reports (SBSRs) that result.

1. #19-018. Chicago Prostate Cancer Surgery Center, Westmont: Permit holders are requesting an additional 12 months (7/31/20 – 7/31/21), claiming projected delays in the inspection/certification/licensure process due to COVID-19, and IDPH's delays in getting teams out.
2. #19-032. Greater Chicago Center for Advanced Surgery, Des Plaines: Permit holders are requesting an additional 14 months (3/31/21 – 6/30/22), citing unanticipated design flaws needing correction, and delays in getting IDPH inspection teams out for inspection/certification/licensure.

The permit holders furnished all information, and no negative findings result. Please review the attached documents, and if you have questions, please do not hesitate to ask. Chairwoman Savage has the authority to render her decision on these renewals in the absence of the full Board. However, your input is always appreciated. Thank you for your service.
