I am a board certified physician in family medicine providing outpatient care to patients throughout Lake County. I admit my patients to Advocate Condell Medical Center. I am sending this letter to express my support for the Certificate of Need (CON) request for approval to build a 60-bed inpatient rehabilitation hospital, Encompass Health Rehabilitation of Libertyville, LLC. In my role as a family practitioner, I see the need on a daily basis for intensive inpatient rehabilitation for patients who have suffered a stroke, brain hemorrhage, cerebral tumors, spinal cord tumors, amputations, traumas and neurological conditions. These patients do not have access to an inpatient rehabilitation facility in Lake County or the surrounding areas.

Inpatient rehabilitation is critically important for the population of patients I take care of. The availability of advanced rehabilitation technology close to home of the patient and family members is critical in the patient's successful road to recovery.

In my 24 plus years as a family practice physician in Lake County, I've learned and experienced that this service is limited or access is denied by others that do offer inpatient rehabilitation. Since Vista Health System closed their Inpatient Rehabilitation Center, patients and families are traveling over 40 miles to the City of Chicago or further to receive this care. When the patients do get approved and transferred to an inpatient rehabilitation bed, I never see these patients back for follow-up care in my practice. I can't emphasize enough the importance of patients receiving continuity in their healthcare, both as inpatients and outpatients, close to home. My patients in Lake County and the surrounding area deserve to have all of their healthcare needs met for inpatient rehabilitation close to home.

As I close, I request the approval of the CON for Encompass Health Rehabilitation Hospital of Libertyville, LLC.


Dear Ms. Avery:

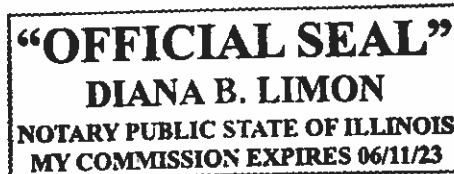

