I am a board certified and fellowship trained internal medicine and cardiologist practicing in the Quad Cities for many years. Cardiovascular Medicine, P.C., includes 10 Illinois physicians trained in cardiovascular medicine whose focus is the comprehensive medical and interventional care of cardiovascular conditions. This letter contains referral documentation required per III. Admin. Code Section 1110.205(b)(3)(A)-(B). Over the past twelve months, we treated 398 patients who would have benefitted from comprehensive rehabilitation care or could have been referred for comprehensive rehabilitation care. A list of these patients by zip code of residence is also attached.

Based on our historical referrals, we would anticipate referring 119 patients each year to the Quad Cities Rehabilitation Institute as proposed by the applicant, if approved.

I further certify that the aforementioned referrals have not been used to support another pending or approved certificate of need permit application. The information provided in this letter is true and accurate to the best of my knowledge.
