Dear Ms. Nichols:

On October 22, 2019 the Illinois Health Facilities and Services Review Board (State Board) approved your request for discontinuation of a category of service. The approval was based upon the application's compliance with applicable provisions of 77 ILAC 1130.500, 77 ILAC 1130.525 and 77 ILAC 1110.290. The exemption is for the discontinuation of the 25-bed acute mental illness category of service at AMITA Health Alexian Brothers Medical Center Elk Grove Village, 800 Biesterfield Road, Elk Grove Village, Illinois. The following categories of service and beds remain:

You are reminded that this exemption requires that for discontinuation of a category of service a notice of project completion must be submitted to the State Board no later than 90 days following the project completion date (November 30, 2019). Failure to provide the required notification shall subject the exemption holder to the sanctions provided under Section 14 of the Illinois Health Facilities Planning Act.

The State Board's approval does not exempt the transaction from any other regulatory, certification or licensure requirements that may be applicable prior to discontinuation.
