Mike,

As a follow up to our discussion, I confirmed Infinity Healthcare ("Infinity") was named in the Rock Island County Board (the "County Board") resolution because it is a recognized health care consulting firm that shares common ownership with the buyer. The County Board resolution was drafted well in advance of the meeting, prior to the formation of the property owner entity, and at the time the resolution was considered, the County Board recognized Infinity was a placeholder for the property owner as the resolution permit the sale of the Hope Creek Care Center to Infinity or its permitted assignee.

Based on our analysis of the Health Facilities and Services Review Board rules regarding necessary parties to a certificate of need application, we do not believe Infinity, which may provide consulting services to Hope Creek Nursing and Rehabilitation Center, LLC (the "Licensee"), should not be a party to the certificate of need application.

- Hope Creek Nursing and Rehabilitation, LLC will hold the license for the skilled nursing facility.
- As a consultant, Infinity will not have final control of Hope Creek Nursing and Rehabilitation, LLC
- This project will be funded entirely with cash, so there will be no debt to guarantee
- Infinity may provide consulting services, but control of the day-to-day operations and provision of care will
 reside with Hope Creek Nursing and Rehabilitation, LLC and 4343 Kennedy Drive, LLC (the property owner) will
 maintain control of the equipment and other capital assets.

Finally, I checked the HFSRB website, and it appears no public hearing was requested for Hope Creek. Can you confirm?
