As you know, we are counsel to Mercy Hospital and Medical Center ("Mercy Hospital") and Mercy Health System of Chicago ("Mercy System, and collectively with Mercy Hospital, "Mercy") on Project No. 20-039. In light of the fact that Mercy and Insight Chicago Inc. ("Insight") have consummated the change of ownership transaction set forth in COE Project No. 003-21, Mercy is hereby withdrawing Project No. 20-039 as moot. 
