On December 14, 2021, the Illinois Health Facilities and Services Review Board ("HFSRB") approved Project #20-040, an application to establish an ambulatory surgical treatment center. The facility will be located at the Northeast corner of Alft Lane and Westfield Drive in Elgin, Illinois 60123. The original project completion date is March 31, 2023, and the purpose of this letter is to request a Permit Renewal pursuant to 77 Ill. Admin. Code 1130.740. Enclosed you will find a check with the permit renewal fee and the late processing fee. This is our first renewal request.

### **Request Project Completion Date**

The permit holder requests that the HFSRB grant a permit renewal and establish Monday, October 30, 2023, as the project completion date for this project.

# Status of the Project

Substantive construction of the Project is complete at this time. The Permit Holder is in the processing of submitting their request for survey by IDPH Life Safety Division and expect that to occur in the coming weeks. Following that inspection, the Permit Holders will request a licensure survey to complete the project. The Project has been financially committed through the execution of a contract with the general contractor for the project.

## **Statement Regarding Project Completion**

The delay in completion of construction of the project was the result of issues related to supply chain for construction materials and in addition the ability of the contractor to maintain sufficient labor force to complete work associated with the project.

## **Confirmatory Evidence of Permit Compliance**

Enclosed is a verified statement from Anthony Brown, Chief Executive Officer for OrthoIllinois that confirms the permit holders are currently complying with the scope, costs, and conditions of the project approved by the HFSRB, pursuant to the permit letter issued for this project. Additionally, the aforementioned verified statement confirms that there are sufficient financial resources available to complete this project.
