The above-referenced Permit was issued by the HFSRB on 01.26.2021, and addresses the modernization in AMITA Health Mercy Medical Center, Aurora, IL.

The scope of the project has remained generally consistent with that provided in the CON application, and the project continues to be funded by cash, as proposed in the CON application.

To date, approximately \$15,894,905.00 has been spent on the project, suggesting that the project is approximately 68% complete. The primary project components that have been completed include: demolition, structural, partial rough framing, mechanical, plumbing, and electrical rough work. Millwork, finishes, and MEP trim work have been completed in certain areas as required in project phasing.

Still to be completed are mechanical, electrical, plumbing, rough, and trim, millwork, finishes, doors, and equipment installations at the final phases.

A table, identifying the estimated costs incurred as of January 2023 is attached.
