• I have seen firsthand the community can NOT support 2 hospitals. The community had 2 hospitals in the past with St. Mary's unable to sustain its business resulting in selling to Blessing Hospital .The population in Quincy is declining, not expanding.

• Due to national , regional and local nursing shortage, it is challenging in current state to find the workforce/Registered nurses for one hospital, let alone supporting a second one.

• Blessing health system uses the dollars provided by federal funding to support the safety net services in the area. One of the areas who benefit from this is the Behavioral Health . I am emailing today in opposition of the Quincy Medical Group application for a secondary hospital in Quincy, IL. I do not believe this project is being proposed to serve our community; I believe it is primarily being proposed as a money-grab opportunity for the sole benefit of QMG stakeholders. Blessing Hospital has met the needs of Quincy sufficiently for over 140 years. QMG has never had to pay for an inhouse pharmacy, cleaning staff, dietary staff, etc.- the basic services that every hospital must provide. I, quite frankly, do not know how they will be able to afford hiring additional staff to provide such services. Additionally, Blessing Hospital currently has more than 50 open RN positions, with no local RNs to fill those roles. How would QMG fill necessary RN positions when our market is dry? And what does it say about an organization that would intentionally harm the community's truly nonprofit hospital by poaching staff? More importantly, what does it say about an organization that would intentionally only serve the insured population in our community? Their proposal states it would be a non-profit hospital, but with the limited size and offerings, I firmly believe that every Medicaid patient who walks through their doors would be transferred to Blessing Hospital "for a higher level of care," wasting precious moments when a pt. could be receiving treatment. This project has been brought for consideration to the Planning Board and the following concerns are being voiced and are needing to be strongly considered.

1. QMG is misrepresenting itself as a locally owned physician group. Since its original application QMG is now been acquired by DuPage Medical Group as a part of a series of strategic investments the for-profit Chicago based company has been making in the last few months.

2. The distance between Blessing Health and the proposed hospital is less than 2 miles therefore the QMG hospital does not impact access to healthcare in a rural community.

3. Sustainability. Current population and trends suggest the area is unable to financially support two hospitals. Population demonstrates a decline from 40,428 in 2018 to 39,652 in 2022. The average decline per year has been .25%. The local area surrounding Quincy is also showing a decline in population of .34% annually. 16% of the population mentioned is considered at or below poverty level and would not be eligible for services at the QMG hospital. 6,344 people (16%) do not financially qualify to be served at this facility.

4. Past history has proven the community has been unable to financially sustain two hospitals.

5. Critical staffing need for RNs, CNAs in our community. This facility will add an additional strain on the available workforce to healthcare facilities that are already established and serving our community.

6. This facility will impact the availability of federal funds that help support safety net services provided by Blessing Health System. The costs could be millions of dollars lost due to approval of a facility that will not be nor ever will provide any of those services.

Blessing Health System has improved and supported efforts of improving access to healthcare in our rural community. Blessing has partnered with struggling rural access hospitals to help keep access points open that would have been financially forced to close without Blessing providing the needed support and resources. As a non-profit organization Blessing meets the needs and takes on the financial risks associated with meeting the needs of our most vulnerable population. Blessing Health System provides, Mental Health services, trauma, critical care, high risk maternal and infant care just to name a few of the services offered

Finally, this proposed hospital is a threat to the existing and established health

system in our community. QMG and their new DuPage owners are focused on providing services that have the most positive financial gain for themselves.
