Dear Ms. Friedman:

On May 4, 2020, the Chairman of the Illinois Health Facilities Planning Board (State Board) acting on behalf of the State Board under 77 IAC 1130.560(b) approved your request for a change of ownership exemption. The approval was based upon the application's compliance with applicable provisions of 77 IAC 1130.520. The exemption is for Advocate Health and Hospitals Corporation d/b/a Advocate BroMenn Medical Center, 1304 Franklin Avenue, Normal, Illinois. The entity to be licensed is Carle BroMenn Medical Center. The exemption involves a purchase resulting in the issuance of a license to an entity different from the current licensee. The acquisition price/fair market value is approximately \$119 million. The category of service and the number of beds remain unchanged as listed below:

You are reminded that this exemption is not transferable or assignable. To demonstrate completion of this transaction, the exemption holder must provide the State Board with the date that the ownership change occurred and provide a copy of the license or certification issued pursuant to

the change of ownership. Failure to provide the required notification shall subject the exemption holder to the sanctions provided under Section 14 of the Illinois Health Facilities Planning Act. The exemption holder is also reminded that 77 IAC 1130.140 defines transactions that constitute a change of ownership of a health care facility. You should become familiar with those definitions.

The State Board's approval does not exempt the transaction from any other regulatory, certification or licensure requirements that may be applicable prior to acquisition. The exemption will be invalid should the facility for which the change of ownership was granted cease to be an existing health care facility as defined in 77 IAC 1130.140.
