Dear Board Members,

It seems odd to ask this Board to deny Mercy's request to close its behavioral health unit, when the health system has effectively done so already. Still, that's precisely my request.

Mercy has stated publicly the reason for the closure is the unit's only full-time psychiatrist left the company July 19. How much advance notice did Mercy receive? Did Mercy try to find a replacement? Or did Mercy just conveniently wait until the end of the 30-day time period before its requirement of notifying the Board of this so-called "temporary" closure. Under the rules, Mercy is supposed to update the Board on the progress for correcting the issue. Clearly, Mercy had no intention of following the rules and keeping the unit open before this Board made its decision. I believe Mercy should be held accountable for its actions.

As to the larger issue of whether these inpatient beds are needed in this community, I've always heard from experts and advocates we need more inpatient services, not less. Mercy claims low demand for those beds. But why is that? This claim needs to be probed further. Advocates believe Mercy's refusal to accept the types of insurance most mental health consumers use is one reason why the hospital system reports lower patient numbers. It's a self-fulfilling prophecy. In fact, in today's Rockford Register Star, SwedishAmerican's Chief Operating Officer told the newspaper the closure of the behavioral health unit is placing pressure on remaining mental health resources in Rockford, and patients are being forced to seek help outside the area. By granting Mercy's petition, this Board will allow Mercy's leadership to abandon the very situation they're responsible for creating.

Finally, five years ago, Mercy appeared before this Board requesting to build a new hospital on Riverside Boulevard. Its slogan was "one hospital, two campuses." Mercy's President and CEO promised then that the Rockton Avenue facility located in the disadvantaged part of town would not lose anything. But the disadvantaged part of town has lost, including level two trauma emergency services and now the behavioral health unit. This year, Mercy will receive millions of dollars more under the state's new hospital assessment program for Medicaid funding and an additional \$2 million from this year's state budget to help safety-net hospitals.

The state has increased its commitment; now it's incumbent upon Mercy to keep its promise to provide quality health care across ALL our community.

Dear Review Board members,

On March 17th of this year, 67% of Rockford voters understood how important mental health services are for our community, their loved ones, for themselves and voted to raise their taxes to fund it. That same day, the state of Illinois announced it's very first death from COVID-19. I'm pretty sure no one suspected that today we will be witness to that total being over 8,000 deaths in Illinois; 147 of those deaths coming from Winnebago County. Alongside those numbers came the shutdown of our schools and businesses that resulted to job loss in the millions just in Illinois.

Then you add the public killing of George Floyd, the civil unrest that followed all while the way one worships being drastically different – mental health services are needed now more than ever. Mental health services will be needed even after 2020 has come and gone due to the residual effects of our current situations. One's mental health is just as important as their physical health, in most cases, even more important.

And that has been the case even before this pandemic happened. Statistically speaking, 1 out of 5 people knows someone dealing with a mental illness – so it's safe to say that we all know too well of the individual with the most beautiful of smiles suffering from depression – or the person who appears to have it all together during the day but pondering suicidal thoughts at night.

Continued Services- Deb Potempa, System CNO

Good afternoon, my name is Deb Potempa and I am a Vice President and the System Chief Nursing Officer for Mercyhealth. Thank you for this time.

I have been working for our system for the past 10 years, and had the privilege of coming to Rockford to support the Javon Bea Hospitals this past year.

In the outpatient setting

As Dr. Dorsey just stated, with the advent of new medications to treat depression, Bi-polar disorders, and other psychiatric illnesses, more patients are able to be appropriately stabilized on medications in an outpatient setting.

Our Primary care doctors routinely screen and engage in treatment and evaluation of their patient's psychiatric needs, and monitor the effectiveness of this treatment if their patient is placed on one of the many medications that may effectively treat their illness.

We are utilizing telehealth technology.

We have seen many benefits in the use of telehealth with the behavioral health population especially during the COVID Pandemic.

- It offers the ability to treat patients outside of the hospital and this provides increased access to care.
- Patients can receive behavioral and mental health services through telehealth in their in primary

care settings. For example, patients can use live-video teleconferencing to receive counseling from a remote psychologist *or mental health counselor*

- We can use telehealth technology to observe the patient in the Emergency Department or on an inpatient unit and to perform assessments, and screenings; and diagnose conditions.
 - We can provide counseling and psychotherapy, which can be delivered to individuals, couples, or groups.
 - Telehealth allows us to help patients adhere to their medication regimens and can help to facilitate coordination with family members, or social services agencies, to meet the identified needs of patients.

- The Glenwood Clinic continues to provide a full time psychiatrist, Dr. Irfan, and offers general psychiatric services and medical management to children, adolescents, and adults. Dr. Irfan also is a part of the psychiatric on-call team supporting the Rockton and Riverside Emergency Departments and inpatient units.

In our Illinois hospitals:

- Our Licensed Clinical Social Workers, and certified Social Workers who worked on the inpatient unit on the Rockton campus will transition to full time psychiatric assessors.

- They will provide support to the emergency departments and the inpatient units on the Rockton and Riverside campus.
- This will be a combination of on-site support and telehealth support.
- They will also work closely with the Case Management nursing team to identify appropriate discharge planning as they currently do today.
- As part of our regional approach, we will begin to share resources from the Wisconsin Behavioral Health program into a larger psychiatric assessment team to serve the Mercyhealth System. The main “hubs” for this program will be the Rockton Avenue campus and the Janesville Campus . Assessors will provide telehealth service to Rockton, Riverside, Harvard, Walworth and Janesville campuses.
- When a patient requires an inpatient admission for behavioral health treatment, we will continue to work with Rosecrance as a referral source as we did in the past.
- We are also continuing to explore opportunities within ~~Swedish American Hospital for Behavioral Health in the Rockford Community~~ as Dr. Dorsey mentioned previously.

Dear Health Facilities and Services Review Board,

Mercyhealth's rapid decision to close their behavioral health inpatient unit does not appear to follow state guidelines and needs to be held accountable for their actions. Mercyhealth's mission to "make lives better" is not a true reflection of the organization when they put profits over people.

A non-profit organization that receives additional incentives from the government and buys out one of the largest hospital chains in our region without pause on how they treat the community they are supposed to serve is **not** a hospital committing to their values. As a nonprofit, under no circumstances should money be the driving factor for Mercyhealth.

A loss of inpatient beds impacts an already strapped mental health system. While there are closer facilities than the heart of Chicago that many patients do choose for care because of quality and specialization over proximity, it is OUR responsibility to ensure access and support for mental health care for residents in Rockford. This is essential through both inpatient and outpatient treatment.

Mental health is just as important as physical health, and if Mercyhealth truly believes in caring for the community, they will not close or be allowed to close this inpatient facility. One in five Americans has a diagnosable mental health disorder, and even if we are not the ones directly impacted, it will be our friends, our family, our neighbors. The individuals living with mental health conditions **DESERVE** and have the right to receive these services.

We know the impacts of mental illness and a lack of treatment; we have seen this since Singer closed. Do we really want to push this down even further and escalate the issue?

If money is what is most important here, above our community's health, then consider ~~the~~ ^{the national} cost of untreated mental illness, which costs about \$100 BILLION dollars a year in lost productivity. The worsening of conditions can lead to lack of job stability, prison, physical health issues, and suicide.

Mercyhealth has failed the Rockford region by showing us their true priorities. We the people **DEMAND** they be held accountable for their actions as we stand up for every individual's right to mental health treatment.

I come before you to urge you to **reject the request by Mercyhealth System to close its inpatient mental health unit located on its North Rockton Ave. campus.**

The need for mental health services in Rockford is absolutely critical and reaches across our community. Every day, we see first-hand what a lack of mental health care does to our schools, our businesses and our neighborhoods. No one is untouched by the challenges of mental illness.

Doing nothing will not make the problem go away and the statistics tell the story. Mental illness is on a frightening rise in the US, according to Mental Health America (MHA), one of our country's oldest mental health advocacy organizations and the National Alliance for Mental Illness (NAMI):

- 1 in 5 US adults experience mental illness each year, while only 43 percent receive treatment.
- More than 10.3 million adults had serious thoughts of suicide in 2017, while the rate of young people 12-17 with a Major Depressive Episode rose from 8.6 percent in 2012 to 13 percent in 2017.
- Depression and anxiety disorders cost the US economy \$1 TRILLION each year.
- 1 in 8 of all visits to an Emergency Department are related to mental illness and/or substance use disorders.
- If just 1 percent of those with Acute Mental Illness needed hospitalization at any given time, we would not have capacity to treat them.
- From August 2019 to August 2020, our Rockford Police Department had more than 500 calls that involved mental illness or mental health issues.
- In Winnebago County, the number of suicides each year has jumped 30 percent in the last decade.
- A minimum of 50 psychiatric beds per 100,000 people is considered necessary to provide minimally adequate treatment for individuals with severe mental illness.
 - Illinois fails to meet this minimum standard.

I concur with SwedishAmerican, whose leadership told me that while they recognize Mercyhealth as a local competitor in the health care field, they believe the greater good of our community and the mental health of our citizens is what is most important.

They acknowledged how vital the Rockton campus was to the quality of life on Rockford's west side, and promised to provide significant space for community needs and development. They indicated plans to continue both inpatient and outpatient Behavioral Health Services, acknowledging that they are critical needs in this community. Unfortunately, the emptiness of those promises is devastating to the most vulnerable citizens of Rockford. I urge this committee to deny Mercy's request, for the sake of those with the greatest needs in Rockford.

My name is Melissa Westphal, and I'm a Rockford resident, as well as a member of the NAMI Northern Illinois Board of Directors.

Our organization works to improve the quality of life of individuals with mental illness and their families through support, education, advocacy and hope.

What we continually hear and what you are hearing today is that our region needs more mental health services, not less. Giving Mercyhealth the permission to close its 20-bed inpatient behavioral health unit is not the right decision, especially given everything that's going on in our world today.

Our NAMI board and volunteers have been scrambling since this public hearing was announced to present you with actual data to reflect the need for inpatient mental health care in our community. That task has proven very difficult – while some of our hospitals, first responders, and other partners gladly responded to our requests, others did not, meaning a complete picture of what our local needs actually are does not exist, particularly in reference to how many individuals are referred out of town for inpatient mental health treatment.

Mercyhealth in its COE application said patients can be absorbed by SwedishAmerican Hospital and KSB Hospital. Just this week, SwedishAmerican was quoted in the Rockford Register Star as saying, "On average, we have been 90% full since Mercyhealth closed their psychiatric services in Rockford. When we reach our capacity of 20 adult patients and someone is in the emergency department needing inpatient care, we are forced to transfer the patient to another psychiatric facility, which is sometimes significantly outside our area."

KSB told us they were not aware of anyone from Mercyhealth reaching out about absorbing the need. So much for "community" needs.

That's reason No. 1 why this board should not approve the certificate of exemption for Javon Bea Hospital – Rockton Avenue. More information and data are needed before this decision should be made.

The second reason is because our citizens recently approved a tax increase in the spring to support and create more mental health services in our community – not less. The closure of this unit couldn't come at a worse time. The recently

appointed Winnebago County Mental Health Board is researching our community needs to determine how to augment and where to add services.

Giving Mercyhealth the permission to permanently close its unit would make it more difficult to reopen in the future. Again, an example of bad timing.

The third reason centers on trust. Mercyhealth has been quoted in news articles saying they intend to keep outpatient services at Rockton Avenue. But how can we trust them based on the sheer number of services being eliminated or reduced just this year?

In timelines you have and will see presented from other people, Mercy reduced its Medicaid offerings in April, closed its PICU in June, filed to close the behavioral health unit in July and consolidated emergency services in August.

I hope you can see why it's difficult to trust that mental health services will remain a priority.

Giving Mercyhealth the permission to close its inpatient behavioral health unit is the wrong decision – period.

I know the lasting impacts of not receiving adequate mental health care as I lost my 19 year old son Tommy to suicide as a result of depression six years. *We cannot put a price tag on lives like Javon Bea has.*
Real Numbers
Statistics show that suicide deaths in and around Winnebago County continue to rise year after year. Our City of Rockford Police respond to an average of 2-3 suicidal subject related calls per day and another 1-2 for drug overdose related calls. The City of Rockford Fire Department responds to an average of 10 mental health/overdose related transports a day with the Mercy-Rockton campus receiving the second largest number of patient transports.

Mercy has failed their commitment to our community. Mercy would like us to believe that there is no demand for their services, hence no need. But the truth is Mercy deliberately and premeditatedly created "no demand" by systematically eliminating the people who needed their services the most by refusing their insurance coverage.

What does it say about Mercy Health ignoring the needs of people coping with severe mental illness in their times of crisis by increasing the barriers to treatment access and then using those barriers as the reason to file this petition. This is clear discrimination against the people who need the protection of quality mental health treatment.

Mercy Health is dodging their responsibility to provide this community with quality health care.

If Mercy's petition for Certificate of Exemption is granted, 20 treatment beds will instantly disappear from our community. Without another hospital petitioning for the expansion of their acute mental illness bed allotment, our citizens in need of immediate care will have to compete for care instead of receiving it. Generations of Christians were harmed by clergy and church leaders who suggested prayer as a substitute for professional mental healthcare, but I and so many others affirm an approach of "prayer AND," meaning that prayer and a psychiatrist, prayer and medication, prayer and treatment are needed to face a mental health diagnosis. It is a deeply faithful thing to seek mental health treatment.

We have worked to celebrate the God-given wisdom of mental healthcare professionals and encourage those in our congregations to get care when they need it, but ^{MercyHealth} you have made a fool of us by taking away mental healthcare options and making it much more difficult for people to receive needed mental healthcare in a crisis. People are not products – you can't just outsource them to the nearest backup hospital. According to Need Determination documents provided by IDPH - Rockford and its surrounding area requires a minimum of 77 inpatient psychiatric beds. The proposed closure of 20 licensed beds at Mercyhealth would mean our area would be left 21 below the IDPH minimum. Please note- Mercyhealth is licensed for 20 beds but has, for years, operated with 14 or less. The data presented in this petition is therefore skewed to show underutilization, justifying closure. I do not need to break down rudimentary statistics for you to recognize that data representing the volume of this unit is **purposefully** inaccurate.

Their slashing of beds in Janesville also speaks to Javon Bea's occupancy false promises
This unit already closed without approval on July 17th due to alleged staffing issues. Mercyhealth still employs multiple psychiatrists. The supposed lack of coverage is not because of an inability to find qualified individuals, it is due to Mercy's refusal to retain and appropriately utilize them. This was an **active, calculated** choice-not a "difficult" one.

To suggest that the loss of these services can be replaced by an outpatient clinic with a several month wait list is reckless and actively puts lives in danger. Outpatient mental health treatment is NOT an adequate solution for someone in an acute psychiatric crisis.

Additionally,

The emergency department environment is not a therapeutic one for patients potentially waiting days for an accepting facility. Emergency medicine doctors and nurses cannot be expected to take the place of psychiatrists skilled in psychopharmacology or social workers trained in various therapeutic techniques.

The presented solution is to transfer patients to outlying psychiatric facilities which are disappearing at an alarming rate.

Chicago Lakeshore Hospital closed its doors to inpatient services last year- resulting in a loss of 161 beds

Our other local hospitals cannot be expected to absorb this demand.

Alarming, patients without funding have two options-to pay their daily rate of approximately \$1500 a day up front or be referred to the closest state facility. Elgin Mental Health Center, which serves Winnebago County, only has one civil unit. Yesterday intake workers at Elgin estimated the wait for their services is at least 10 days.

Most of the facilities within 100 miles are free standing psychiatric hospitals. They are not within a larger medical hospital, lacking the capability of monitoring and treating many common health issues, making transfer at times impossible. Many are also for-profit: they do not have to play by the same rules as nonprofit systems and can deflect for seemingly any reason. They see medical comorbidities and complexities as a liability.

Common reasons for deflection from a stand-alone psychiatric facility include:

- Pregnancy
- Autism
- obesity
- Cardiac concerns
- Epilepsy
- Diabetes
- Cancer
- Legal history
- Aggression
- Self harm
- Homelessness
- History of Noncompliance with treatment

Most patients requiring psychiatric admission meet at least one of the aforementioned criteria

Mercyhealth's unit remains an essential service to this city.

It will result in irreversible damage to our community. Please do not allow executive mismanagement of resources to result in permanent loss of services for this increasingly vulnerable population.

Dear Review Board,

The Winnebago County Mental Health Board is disheartened by Mercy Health's request and subsequent actions to close their mental health beds. We find this inconsistent with mental health trends and community need.

Mental Health Trends

A growing body of evidence suggests increasing rates of mental illness. For example, depression among Medicare users has increased from 15.28% to 17.93% from 2011 to 2017 on a national level and from 16.11% to 17.93% in Winnebago County¹. From 2004 to 2016, suicide mortality (age-adjusted) rates have increased more than 20% nationally and more than 30% in the State of Illinois². Children's mental health trends are also concerning with suicide rates for children ages ten to fourteen tripling from 2007 to 2017³

While mental illness was already on the rise prior to the COVID-19 pandemic, recent research suggests greater psychological distress during the pandemic for people with serious mental illness,⁴ a trend which can be predicted to increase the number of psychiatric crises and, in turn, the need for mental health hospital beds. These trends suggest a need for more community mental health beds, not less. In fact, research has demonstrated the need for 50 psychiatric beds per 100,000 people⁵. In absence of adequate community beds, individuals in psychiatric crisis fill up our emergency rooms, jails, and prisons.

Community Need

Consistent with mental health trends, Mercy has seen an increase in admissions for acute mental illness – up to 593 in 2018 from 570 in 2015. It is only because the average length of stay has decreased that the average daily census has decreased. Yet, it is hard to understand how this request fits with Mercy's own assessment of community need. According to Mercy Health's FY2021 Community Benefit Plan^{6a}

key area of community need includes improving the behavioral health status of community members with a noted tactic to “continue to provide inpatient and outpatient medicine service to area residents.”

It is worth noting that Mercy Health’s North Rockton Ave Campus does not reside in a designated Health Professional Shortage Area (HPSA) for mental health⁷. While we understand the overall difficulty of attracting psychiatrist to the region, we find it unconvincing that this is an impossible task or a legitimate reason for closing down a much needed service in our community.

We ask that you please take into consideration the preceding information and rule in favor of keeping these much needed beds in our community.

To whom it may concern —

My younger brother Eli has suffered from mental illness / schizophrenia for the last 15 years. It came on suddenly when he turned 22 and unfortunately, his case has proven to be severe. Even when on meds, he requires a few hospitalizations a year (sometimes many more). The illness can be managed, but it will never go away. Learning and dealing with the mental health system in Illinois has been a rough ride, especially for my parents.

Budget cuts under Bruce Rauner closed every single long-term mental care facility in the Rockford region — there are no more full time care facilities for people like my brother. Recently, any remaining group homes / assisted living facilities have closed their intake due to COVID concerns. It's estimated that one third of all inmates in IL prisons are mentally ill (we closed the mental asylums, only to replace them with prisons, where the mentally ill receive a fraction of the care they need, and are vulnerable to attacks from other inmates or correctional officers.)

If the Rockton Mercyhealth campus closes for mental health care, the remaining immediate care hospital (Swedish American) only has about 20 beds for mental / behavioral patients. When those beds are full (and they frequently are — in our 15 years of dealing with my brothers' illness, more than half the time there have been no beds available), patients are either denied care, simply turned away, or at best, shipped off into Chicago or further away for treatment. We've been through this a hundred times (unfortunately, not an exaggeration). My brother has been sent to Aurora, far south Chicago, St Louis, and beyond. Of course, this makes follow-up care and family support incredibly difficult, so the likelihood of repeat hospitalization goes up. We've heard the term "revolving door patient" entirely too many times.

Now Javon Bea is seeking to discontinue the mental health services at MercyHealth on Rockton. They're saying that there's not enough demand, that there's only 2-3 mental health calls per day. I can only give my personal / anecdotal evidence. Despite my brother being admitted to that hospital many times over the years, the last few times we've taken my brother to RMH (most recently this year, Feb 4) in the midst of another psychotic episode, he has been refused care — either the beds are all full, or the nurses said "He needs acute care and we can't help with that." According to nurses I've spoken with, the numbers are being fudged to make it easier to remove this service from the Reckon Avenue Mercyhealth. Of course, it's easy to claim there's only have 2-3 patients a day, when a hospital refuses to admit patients.

I believe that our elected leaders and now, CEOs of multi billion dollar hospital conglomerates, are truly failing the "least of us," the people who can't stand up for themselves.

Good afternoon, my name is Susan Schroeder. I am the CEO at Stepping Stones of Rockford, Inc. We are a community mental health center located here in Rockford. Stepping Stones serves individuals who are 18 and older and have a serious mental illness. The most common diagnoses are schizophrenia and bipolar disorder. All individuals have Medicaid or a Managed Care Organization (MCO) as their insurance and Social Security Income or Social Security Disability Income to pay for their daily needs. The vast majority of individuals we serve live in homes and apartments that have some level of staff supervision.

In spite of this supervision, individuals will at times require inpatient psychiatric hospitalization. Our treatment approach is to ensure continuity of care when individuals require care outside of our program. With the individual's permission, we speak with the hospital staff to discuss their typical level of functioning. We attend staffing's to assess readiness to return home. When hospitalized in Rockford, we provide transportation and help to settle them back in their home once they are discharged. When individuals are hospitalized outside of our community, this continuity of care process is very difficult and often times impossible.

In the past 3 years, Stepping Stones has had individuals require inpatient psychiatric hospitalization on 87 occasions. Of these, 24 were at Mercy Health on Rockton Ave, 15 at Swedish American Hospital, and 48 were hospitalized outside of our community. The majority of the hospitalizations out of town were in Chicago. Over **half** of the individuals requiring inpatient psychiatric hospitalization from our agency alone, were unable to have their needs met in their own community. Shame on our community.

When people require hospitalization for physical health needs, they are never sent to another hospital or town due to lack of beds, yet this happened **more times than not**, when individuals we serve required psychiatric treatment in a hospital. How do people get to the hospital in Chicago for a psychiatric admission

you might ask, they are most frequently transported by ambulance at tax payers expense.

The data I just gave you is from Stepping Stones alone. We are a small organization. What must these numbers look like when considering all who live in Rockford and the surrounding communities who require inpatient care?

According to the recently released 2020 Healthy Community Study a 27% of the respondents reported having at least one mental illness or behavioral health issue. These rates are comparable to State and National findings, which show that 1 in 5 adults have been diagnosed with a mental illness. One in twenty-five people experience a serious mental illness.

Rockford Fire/911 reports that thus far in 2020 they have responded to 1001 individuals calling for a mental health need. Of those, they transported 943 to one of our local hospitals. In addition, between August 18, 2019 and August 18, 2020 the Rockford Police Department has transported 121 individuals requiring psychiatric evaluation, responded to 842 individuals who were despondent or suicidal, and were called 26 times for individuals who took their own lives. These numbers are only from two departments responding to individuals requiring assistance for their mental health needs. These numbers do not include the Winnebago County Sheriff or surrounding police and fire departments.

The people who live in the area which surrounds the Mercy Health Rockton Avenue campus already have a more difficult time accessing needed services. Many are unemployed or under employed, live in poverty, have food insecurity, are socially isolated, have housing instability and have had adverse early life experiences. These factors often are a predictor of poor mental health and an increased risk of mental illness. Mercy Health made a commitment to this community when they built the new hospital on Riverside. They are not keeping this commitment and are making getting treatment more difficult for those who need it most.

Mercy Health speaks of the cost to their hospital system as a reason to stop providing services to individuals with Managed Care as their payer source as well

as to close their inpatient psychiatric unit. What about the cost to people and our community? 20% of people experiencing homelessness also have a serious mental illness. \$1 trillion is lost in productivity each year due to depression and anxiety disorders. 37% of people incarcerated in state and federal prisons have a diagnosed mental health condition. 70% of youth in the juvenile justice system have at least one mental health condition. Suicide is the 2nd leading cause of death for people ages 10-34 and the overall suicide rate has increased 31% since 2001. 1 in 8 visits to emergency rooms in the United States are related to mental illness and/or substance use disorders. Mood disorders are the most common cause of hospitalization for all people in the US under age 45 excluding hospitalization related to pregnancy and birth.

On behalf of the individuals served at Stepping Stones and of all individuals in our community and surrounding area who at times require inpatient psychiatric care, I respectfully request that this committee deny Mercy Health's application to close their inpatient psychiatric unit. Our community needs additional inpatient psychiatric beds not fewer.

Good Afternoon,

I am Carlene Cardosi, Chief Operating Officer for Rosecrance incorporated. Rosecrance has been asked numerous times to give our opinion regarding the closing of the psychiatric unit at Mercy. However, we are unable to speak to Mercy's utilization patterns, nor the specific reasons or merit as to why they have closed this program. We can support and attest to Mercy's statement regarding a severe shortage of psychiatrists for this region, and for that matter nationally. Rosecrance relies heavily upon the use of video-psychiatry for this reason.

I can specifically report on the amount of mental health crisis calls and interventions that Rosecrance responds to in this area. During the last 12 months, Rosecrance has provided crisis services to an estimated 900 adults, the vast majority have been stabilized at our crisis triage center on Mulberry St. For those requiring hospitalization, we referred 26 to SAH, 28 to Mercy hospital and 62 clients out of the county for hospitalization due to insufficient beds. We are concerned about making certain there are an adequate number of acute beds to meet the needs of this community, and hope to avoid moving anyone from this region out of county for care.

We are also unable to speak to Mercy's plan on serving those who seek crisis services at their locations. We had discussions earlier this summer regarding a possible partnership with Mercy in assisting clients in crisis, similarly to services provided at other local hospitals, however leaders from Mercy have reported they are working on an alternate plan.

Especially at the present time of the Covid-19. Yes we are all struggling with the economic lost to our community. At this time the County, City, Business, individuals that have lost their jobs and health insurance and the list goes on. We have all had to make adjustments to our budgets.

Closing the NICU that MHS has been advertising on Television and other media as the top rated Center in Northern IL. Eliminating the Mental Health and Substance abuse beds. Which at this time, when the community is in crisis and needs these services more now than ever.

Over the past 5 or 6 years MHS have continued to close different services and dismiss personnel. Again MHS is threatening to dismiss 1300 more staff if The city of Rockford will not replace a Storm sewer that runs in front of the Rockton Campus. In 2018 during a heavy down pour their basement flooded. All the other properties surrounding the campus had no trouble. But MHS insist it is the city's problem and their attorneys has a law suite against the Mayor and the City Council on their behalf.

MHS has also stated that they would continue services if Medicaid would pay them the actual cost of services. Believe me if they can perform that miracle every provider in the State of Illinois would be able to balance their budgets.

Like I said at the beginning I am very disappointed in Mercy Health Services. They should take the Mercy out of their name because they show no mercy to those in most need.





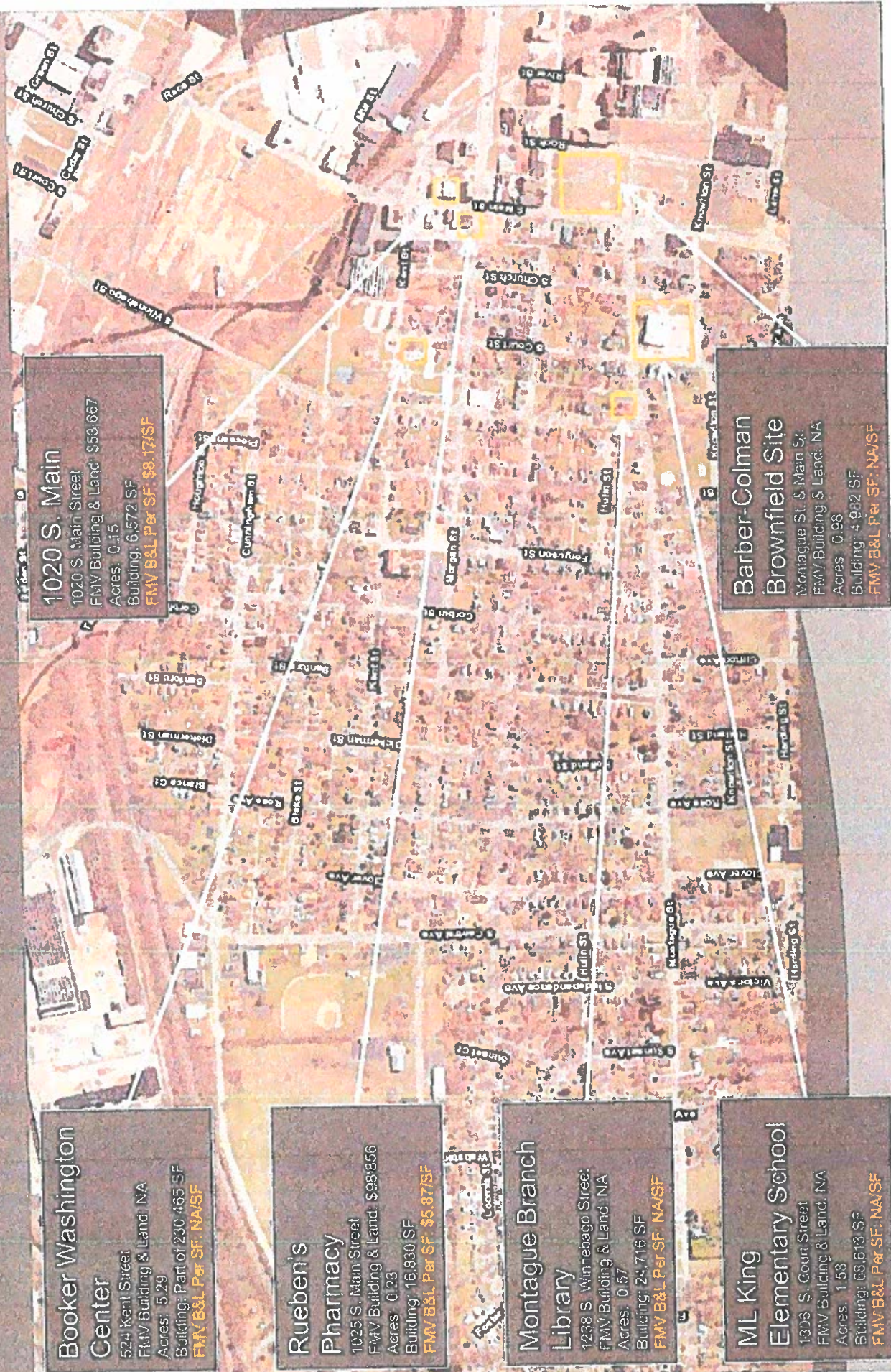

MercyRockford's Responsibility to the West Side of Rockford

It was a grand day on November 17th with the Illinois Health Facilities and Services Review Board unanimously approved our Certificate of Need application from MercyRockford Health System to create "one hospital on two campuses." Equally impressive, all eight board members of the Board voted in favor of our project.

In the December issue of Insight...the news for Rockford Health System Employees publication, Javon Bea, president and CEO of MercyRockford, wrote, "It's important to remember those in the community who supported the project." Representative Litesa Wallace was cited in the article saying the vote was "the right thing to do, but the pressure from the opposition did not make it easy".

Rep. Wallace was indeed right...those who represent the west side of Rockford were pressured and criticized for their decision. They were accused of selling the west side of Rockford out. Alderwoman Venita Hervey led the opposition but many west side residents joined Ms. Hervey in assuming that MercyRockford Health System would not be true of their word. In their minds, we wouldn't improve the Rockton Campus. We wouldn't keep Rockford Memorial Hospital as a vibrant and critical facility. Ten years from now, they feared that the west side of Rockford would be worse off than if the CON request was denied.

In addition to Rep. Wallace, many west Rockford leaders supported our request.

In total, 30 community leaders offered comments supporting our request at the hearings. Indeed all contributed, but no one would contribute more than those noted, and surely, no others took a bigger risk than those noted.

Next Steps to Honor Speakers who Represented West Rockford

President Bea has promised that the N. Rockton campus will receive no less than \$8 million per year in the future. In addition, the Rockford Clinic building on the Rockton Campus will be available to organizations that serve the community. Bea was quoted as

saying that "this is another way we will transform the campus while strengthening partnership and creating job opportunities in the neighborhood."

Bea's promises are both significant and relevant. They may assure the vitality of the N. Rockton campus well into the future. However, these promises are future-driven. They do not address the pressing and current needs of the west side of Rockford. It will likely be three years, or more, before the Rockford Clinic will be available for productive initiatives. The west side of town needs support this year. Its citizens need training, education and jobs now. Every year that we wait will prevent progress.

Charting a path for change.

The west side leaders who supported our CON request are banking on MercyRockford Health System to engage West Rockford soon, and not only with excellent healthcare, but also, to provide a catalyst for West side progress. The pastors and leaders who supported MercyRockford are hoping that MercyRockford will make the west side of Rockford to a better place. This was fundamental to the Rockford Minister Fellowship's decision to support our expansion plans.

How can MercyRockford help West Rockford?

- **Partner with companies that are creating West side jobs.** Rockfast is a public-private partnership to create a Manufacturing Incubator Center, combined with training and employment center at 1310 Preston.
- **Consider using the products made on West Rockford.** Companies are seriously bringing a LED lighting company to 1310 Preston. Also, a group of entrepreneurs are considering building a commercial laundry on the west side of Rockford, if the regional hospitals will give them their business. Most or all of the employees would be west Rockford residents. Engaging these companies at this time would increase the likelihood that they would come to our community.
- **Train unemployed West Rockford job seekers** in the attitudinal and characteristics of keeping a job. Mr. Larry Williams has developed a program that results in high job placement and strong job retention.
- **Listen to the leaders who supported our CON request.** When warranted, support viable endeavors that will improve West Rockford Health System.

Know what are competition is doing

It is important to know what OSF and SwedishAmerican Hospitals in our community. We should provide comparable service to our competition, with a focus on the west side of Rockford.

- SwedishAmerican Hospital has spent \$6 million in revitalization projects in the Jackson Oaks neighborhood, to fix up homes. The hospital campus benefits by improving the community close to its hospital and the community benefits by stabilizing the value of its houses.
- OSF Health Center will be training paramedics to join Belvidere SWAT teams. Also, OSF has partnered with Rock Valley College to share a new, modern College of Nursing. Without OSF's capital contribution the building would not have built on the RVC campus.

Summary

It is important for MercyRockford Health System to determine its contribution to community. Community leaders stepped up to support MercyRockford's CON request, hoping that would provide benefit to West Rockford. MercyRockford can be proactive in determining and announcing our intentions, before our advocates come to us for support.


