Advocate Lutheran General Hospital is pleased to submit our annual progress report on the Project referenced above in accordance with the requirements of the 77 III. Adm. Code 1130.760. The Project includes the modernization of several surgical rooms and pre-operative areas. The Review Board granted the permit for this Project on April 22, 2021.

### 1. Current status of the Project:

#### **Obligation:**

 The Project was financially committed (obligated) with a Purchase Order #90016234 to Power Construction on May 7, 2021, in accordance with 77 III. Adm. Code 1130.760.

#### Components of Project finished:

- Percentage of the project finished: Construction is approximately 99% complete.
- The modernization of Pre-Op/Phase II Recovery, OR #6, OR #20 and ORs #1-5 are generally completed.

#### Components yet to be finished:

Change order processing and final payments are final items to be completed.

# **Commitment of Funds:**

• As of March 23, 2023, 90% of the total funds assigned to the project costs were expended by signed contracts.

## Changes in scope and size:

 The project remains substantially consistent with the scope of work of the Project as approved by the Review Board.
