On December 15, 2021 the Illinois Health Facilities and Services Review Board (IHFSRB) approved the permit application for our project. The approved permit was approved with a December 31, 2023 project completion date.

Although we have completed construction and received occupancy for business operations from the IDPH, we are awaiting their visit to review the clinical operations for licensing. Accordingly, pursuant to Section 1130.740, we respectfully request a Permit Renewal. The details follow below:
