In accordance with the requirements of the Illinois Health Facilities Planning Act, notice is given of receipt to establish a Long-Term Acute Care (LTACH)/Rehabilitation Hospital in Chicago. Project #21-026, Rush Specialty Hospital, Chicago. Applicants: Rush University System for Health, Rush University Medical Center, Rush Partners, LLC, Select Medical Corporation, Select Illinois Holdings, Inc., and Rush Specialty Hospital, LLC. The applicants propose to establish a 100-bed LTACH/Rehabilitation Hospital in 134,907 GSF of space, located on the northwest corner of Harrison Street and Loomis Avenue, in Chicago.
