Dear Ms. Goebel:

On March 22, 2021, the Chairwoman of the Illinois Health Facilities and Services Review Board (State Board) acting on behalf of the State Board under Part 77 IAC 1130 approved your request for the discontinuation of the 10-bed acute mental illness category of service at HSHS Holy Family Hospital, 220 Health Care Drive, Greenville, Illinois. The approval was based upon the application's compliance with applicable provisions of 77 IAC 1130. As result of this change the Hospital has the following categories of service and number of beds.

You are reminded that the issuance of the certificate of exemption is contingent upon the submittal of a statement to the State Board within 90 days of the discontinuation of the category of service by the Hospital. To demonstrate completion of this transaction, the exemption holder must provide the State Board with the date that the discontinuation occurred. Failure to provide the required notification shall subject the exemption holder to the sanctions provided under Section 14 of the Illinois Health Facilities Planning Act.

The State Board's approval does not exempt the transaction from any other regulatory, certification or licensure requirements that may be applicable.
