Exemption Holders: Southern Illinois Hospital Services, Harrisburg Medical Center, Inc., Southern Illinois Healthcare Enterprises, Inc.

Dear Mr. Schaeffer and Ms. Blythe:

On July 30, 2021, the Illinois Health Facilities and Services Review Board (State Board) approved your request for a change of ownership of Harrisburg Medical Center, 100 Dr. Warren Tuttle Drive, Harrisburg, Illinois. The approval was based upon the application's compliance with applicable provisions of 77 ILAC 1130. The change of ownership is a change of membership or sponsorship of a not-for-profit corporation that is the licensed entity. The licensed entity and the owner of the site is Harrisburg Medical Center, Inc. Harrisburg Medical Center, Inc. has been approved for 46 medical surgical beds and 31 acute mental illness beds for a total of 77 beds. The fair market value is estimated to be within the range of \$15.5 million and \$19.3 million.

You are reminded that the issuance of the certificate of exemption is contingent upon the submittal of a statement to the State Board within 90 days of the closing date of the transaction that certifies the change of ownership has been completed in accordance with the key terms contained in the application. To demonstrate completion of this transaction, the exemption holder must provide the State Board with the date that the change of ownership occurred. Failure to provide the required notification shall subject the exemption holder to the sanctions provided under Section 14 of the Illinois Health Facilities Planning Act.

The State Board's approval does not exempt the transaction from any other regulatory, certification or licensure requirements that may be applicable.
