Re: Project 22-002 Kindred Hospital Sycamore Establishment of Comprehensive Physical Rehabilitation Annual Progress Report

Dear Mr. Kniery and Mr. Constantino,

Project 22-002, the establishment of a Comprehensive Physical Rehabilitation service at Kindred Hospital Sycamore, was approved by the Illinois Health Facilities and Services Review Board on July 19, 2022. This letter constitutes the first annual progress report, consistent with Section 1130.760.

Construction documents have been completed and the bidding process is actively underway. A/E work required extra time, resulting in a delayed delivery of the CDs. A general contractor has not yet been selected; three are being considered. Each of the GCs requested extra time to accommodate similar time extension requests by subcontractors. As a result, none of the built-in equipment has been ordered. The lead times for acquiring certain equipment essential to the project extend significantly beyond the initial project schedule, due mostly to industry-wide shortages and supply chain issues. Delays apply to the acquisition of new heating boilers, fan coils, electrical panels, air handling units and doors. It is imperative to have this equipment on site at the start of construction in order to maximize installation and construction scheduling efficiencies.

Because of these factors, ScionHealth requested, and the State has approved, an extension of the permit financial commitment date until July 19, 2024, a permit renewal extending the project completion date until April 30, 2025, and an increase in total project cost to \$7,154,326. (Letters from Chair Debra Savage dated May 30, 2023.)

IDPH Design Standards has approved the project for construction. The project will be constructed in space that is not in clinical use, as stated in the permit application. LTAC beds will be reduced from 69 to 54 from the State inventory at the conclusion of the project.

Payments to date total \$299,321.40, 4% of the approved total project cost, as altered. There is no change in size or scope of the approved project. Regarding sources of funds, the project, including the alteration amount, will be funded with cash and securities that will be generated out of working capital, consistent with the approved project.
