NOTICE OF REVIEW AND OPPORTUNITY FOR PUBLIC HEARING AND WRITTEN COMMENT

In accordance with the requirements of the Illinois Health Facilities Planning Act, notice is given of receipt to add stations to an existing End Stage Renal Dialysis (ESRD) facility in Evergreen Park. Project #22-014, Dialysis Care Center Evergreen Park, Evergreen Park. Applicants: Dialysis Care Center Evergreen Park, LLC, Dialysis Care Center Holdings, LLC, and Meridian Investment Partners, LLC. The applicants propose to add 2 ESRD stations to an existing 14 station ESRD facility, resulting in a 16-station ESRD facility located at 9834 South Kedzie Avenue, Evergreen Park. Project cost: \$30,000.
