In accordance with the requirements of the Illinois Health Facilities Planning Act, notice is given of receipt to build out shell space in a newly-built Medical Office Building (MOB), on the campus of an acute care hospital in Peoria. Project #22-016, OSF Saint Francis Medical Center Cancer Care Center, Peoria. Applicants: OSF Healthcare System d/b/a OSF Saint Francis Medical Center. The applicants propose to build out 31,190 GSF of space to establish physician office/clinic space. The hospital is located at 530 Northeast Glen Oak Avenue, Peoria. Project cost: \$13,231,250.
