Project #22-017, Methodist Medical Center of Illinois d/b/a Young Minds Institute, West Peoria. Applicants: Methodist Medical Center of Illinois, Methodist Health Services Corporation, Iowa Health System d/b/a UnityPoint Health. The applicants propose establish a 44-bed Adolescent AMI Hospital, located at 2223 West Heading Avenue, West Peoria. Project cost: \$29,327,856.
