In accordance with the requirements of the Illinois Health Facilities Planning Act, notice is given of receipt to establish a Medical Office Building in Orland Park. Project #22-022, Silver Cross Orland Park Medical Office Building, Orland Park. Applicants: Silver Cross Hospital and Medical Center, and Silver Cross Health System. The applicants propose to establish a Medical Office Building (MOB) in 42,000 GSF of leased space, located at the northeast corner of LaGrange Road and 171st Street in Orland Park. Project cost: \$25,543,836.
