In accordance with the requirements of the Illinois Health Facilities Planning Act, notice is given of receipt to establish an Ambulatory Surgery Treatment Center (ASTC), in Lake Barrington. Project #22-024 Pepper Road Endoscopy Center, Lake Barrington. Applicants: Pepper Road Endoscopy Center, LLC and Fox Glen, LLC. The applicants propose to establish a single specialty ASTC in 4,350 GSF of leased space, located at 22285 North Pepper Road, Lake Barrington. Project cost: \$431,481.
