In accordance with the requirements of the Illinois Health Facilities Planning Act, notice is given of receipt to establish an Ambulatory Surgery Treatment Center (ASTC), in Chicago. Project #22-025 Surgical Center for Human Reproduction, Chicago.

Applicants: Surgical Center for Human Reproduction, LLC, IVF Consulting, LLC, and Pinnacle Fertility, Inc. The applicants propose to establish a multi-specialty ASTC in 7,054 GSF of leased space, located at 680 North Lakeshore Drive, Chicago. Project cost: \$12,188,227.
