Project #22-027 Springfield Clinic- Ambulatory Surgery Center, Springfield. Applicants: Springfield Clinic LLP. The Applicant proposes to add Cardiac Catheterization to the complement of surgical services provided at its ASTC, located at 1025 South Sixth Street, Springfield. Project cost: \$13,094,365.
