In accordance with the requirements of the Illinois Health Facilities Planning Act, notice is given of receipt to modernize a special care nursery unit at an existing hospital in Hinsdale. Project #22-033 Adventist Hinsdale Hospital, Hinsdale. Applicants: Adventist Midwest Health d/b/a AdventHealth Hinsdale and Adventist Health System Sunbelt Healthcare Corporation d/b/a AdventHealth. The Applicants propose to modernize its existing special care nursery containing Level III (NICU), and Level II nursery beds. Project cost: \$21,254,700.
