Pursuant to Section 1130.760 of the Illinois Health Facilities and Services Review Board ("HFSRB") rules, I am writing on behalf of Marklund Children's Home d/b/a Marklund Wasmond Center and Marklund Charities (collectively, "Marklund") to submit the annual progress report for Marklund Wasmond Center. As you are aware, the Marklund has a certificate of need permit to add 24 beds to its existing MC/DD facility located at 1435 Summit Street, Elgin, Illinois (the "Project"). The Permit Holders submit the following information regarding the progress of Project.

The project was financially committed through the execution of the construction contract. To date 50 percent of the Project is complete.

- All sitework, paving and landscaping is complete.
- Phase 1 is complete and the residents and staff are occupying it.
- Phase 2 is well underway. All structural renovations are complete, and the mechanical/electrical/plumbing rough-in is nearing completion.
- North residential Phase 3 will start after Phase 2 is complete.

The Permit Holders have expended \$8,650,000 on the Project to date.
