Dear Mr. Johnson and Ms. Balkan:

On July 2, 2022, the Chairwoman of the Illinois Health Facilities and Services Review Board ("State Board") acting on behalf of the State Board under 77 IAC 1130 approved your request for the discontinuation of the 16-bed obstetric category of service at Advocate South Suburban Hospital, 17800 South Kedzie Avenue, Hazel Crest, Illinois. The approval was based upon the application's compliance with applicable provisions of 77 IAC 1130. The completion date is August 1, 2022. As the result of this discontinuation the Hospital has been authorized for 197 medical surgical beds and 20 intensive care beds for a total of 217 authorized beds. Advocate Health and Hospitals Corporation d/b/a Advocate South Suburban Hospital is the licensee and the owner of the site.

You are reminded the issuance of the certificate of exemption is contingent upon the applicant submitting a statement to the Board within 90 days after the closing date of the transaction, or such longer period as provided by the Board, certifying that the change of ownership has been completed in accordance with the key terms contained in the application. If such key terms of the transaction change, a new application shall be required. Failure to provide the required notification shall subject the exemption holder to the sanctions provided under Section 14 of the Illinois Health Facilities Planning Act.

The State Board's approval does not exempt the transaction from any other regulatory, certification or licensure requirements that may be applicable to this transaction.
