Dear Mr. Lach:

On July 26, 2022, the Chairwoman of the Illinois Health Facilities and Services Review Board ("State Board") acting on behalf of the State Board under 77 IAC 1130 approved your request for a change of ownership of Ambulatory Surgery Center of Centralia, LLC d/b/a Surgery Center of Centralia, 1045 Martin Luther King Drive, Centralia, Illinois. The licensee and the owner of the site is Ambulatory Surgery Center of Centralia, LLC. The change of ownership is considered a change in the control of a licensed health care facility's physical plant and capital assets. The approval was based upon the application's compliance with applicable provisions of 77 IAC 1130. The anticipated purchase price is \$250,000 and the expected completion date is July 31, 2022.

Ambulatory Surgery Center of Centralia, LLC d/b/a Surgery Center of Centralia has been approved for the following surgical services: gastroenterology, general surgery, OB/Gyn, ophthalmology, orthopedic, pain management and podiatry.

You are reminded the issuance of the certificate of exemption is contingent upon the applicant submitting a statement to the Board within 90 days after the closing date of the transaction, or such longer period as provided by the Board, certifying that the change of ownership has been completed in accordance with the key terms contained in the application. If such key terms of the transaction change, a new application shall be required. Failure to provide the required notification shall subject the exemption holder to the sanctions provided under Section 14 of the Illinois Health Facilities Planning Act.

The State Board's approval does not exempt the transaction from any other regulatory, certification or licensure requirements that may be applicable to this transaction.
