Dear Mr. Silberman and Mr. Morado:

The Chairwoman of the Illinois Health Facilities and Services Review Board (State Board) acting on behalf of the State Board under 77 IAC 1130 approved your request for a Change of Ownership of Westmont Surgery Center, LLC d/b/a Salt Creek Surgery Center, 530 North Cass Avenue, Westmont, Illinois. The approval was based upon the application's compliance with applicable provisions of 77 IAC 1130. IBJI Salt Creek ASC, LLC, will become the direct parent company owning 100% of the ASTC. This transaction is considered a change of ownership among related persons that does not result in a license being issued to an entity different from the current licensee. The ASTC has been approved for the following surgical specialties: Orthopedics, Pain Management, and Podiatry.

The issuance of the certificate of exemption shall be contingent upon the applicant submitting a statement to the Board within 90 days after the closing date of the transaction, or such longer period as provided by the Board, certifying that the change of ownership has been completed in accordance with the key terms contained in the application. If such key terms of the transaction change, a new application shall be required. Failure to provide the required notification shall subject the exemption holder to the sanctions provided under Section 14 of the Illinois Health Facilities Planning Act.

The State Board's approval does not exempt the transaction from any other regulatory, certification or licensure requirements that may be applicable to this transaction.
