Advocate Medical Group is pleased to submit to you our Annual Progress Report on the project referenced above in accordance with the requirements outlined in Title 77, Chapter II, Subchapter b, Part 1130, Section 1130.760. The project is for construction of a new 41,739 Square Feet Medical Office Space in Chicago, Illinois.

The Review Board granted approval on 3/21/2023. This is our First Annual Report pertaining to this project.

Project Status

Upon Review Board approval, construction design documents were finalized and issued for permit with the City of Chicago on 9/5/2023. Permit was fully issued on 1/22/2024 with construction start proceeding shortly afterwards on 2/19/2024.

As of 3/21/2024, the General Contractor, The Boldt Company, has executed contracts onboarded subcontractors and procured material to mobilize on site. Floor prep work is actively ongoing in advance of mechanical, electrical, and plumbing installations set to begin in the weeks ahead.

The project is on schedule to be completed on or before 4/30/2025 in accordance with the permit.



Commitment of Funds

The project was obligated on 1/5/2024 by executing a purchase order and fully signed construction contract with The Boldt Company, valued at \$18,400,000 equating to 43.7% of the approved permit value.

Changes in Scope and Size

The project remains substantially consistent with the scope of work as previously approved by the Review Board.

Cost Status

Costs incurred to date as of 3/21/2024 and a comparison of those costs to the approved Permit Amounts are outlined below.
