In accordance with the requirements of the Illinois Health Facilities Planning Act, notice is given of receipt to establish an Ambulatory Surgery Treatment Center (ASTC), in Chicago. Project #23-007, Advocate Ambulatory Surgery Center, Chicago. Applicants: Advocate Health and Hospitals Corporation, Advocate Aurora Health, Inc., and Advocate Health, Inc. The applicants propose to establish a multi-specialty ASTC in 20,202 GSF of leased space, located at 1435-1471 West Webster Avenue, Chicago. Project cost: \$36,956,122.
