HEARING AND WRITTEN COMMENT**

In accordance with the requirements of the Illinois Health Facilities Planning Act, notice is given of receipt to establish a behavioral health (AMI) hospital in Peoria. Project #23-008, Meadowview Behavioral Hospital, Peoria. Applicants: US HealthVest, LLC, I2 Health, LLC, I2 Health Opco, LLC d/b/a Meadowview Behavioral Health, I2 Health Realty, OSF Healthcare System, Pointcore, Inc. The applicants propose to establish a 100-bed AMI hospital in 64,000 GSF of newly-constructed space, on property located between Route 91 and Interstate 6, in northern Peoria. Project cost: \$34,333,404.

The application contained a Safety Net Impact Statement, was approved for expedited review, and declared complete on February 7, 2023.
