In accordance with the requirements of the Illinois Health Facilities Planning Act, notice is given of receipt to establish a skilled nursing and rehabilitation facility in Batavia. Project #23-012, Ignite Batavia, Batavia. Applicants: LBG Batavia, LLC, Ignite Batavia, LLC, Batavia Manager, LLC, Batavia Senior Partners, LLC, and Ignite Medical Resorts Batavia, LLC. The applicants propose to establish a 96-bed skilled care/rehabilitation facility in 62,590 GSF of newly-constructed space, located at 37W284 Main Street, Batavia. Project cost: \$25,349,517.
