The Project is for construction of an additional 11 medical surgical beds for a total of 425 medical surgical beds at the Hospital.

These beds are being developed in combination with the additional 20 M/S beds approved in COE #E-051-22.

The Review Board granted the permit for this Project on June 27, 2023.

### 1. Current status of the Project

**Obligation:** The Project was financially committed (obligated) on May 25. 2023 by signing a construction contract with Power Construction Company obligating 69% of the permit value.

Percentage of the project finished: the Project is approximately 65% complete.
