In accordance with the requirements of the Illinois Health Facilities Planning Act, notice is given of receipt to add beds to an existing acute care hospital in Oak Lawn. Project #23-021, Advocate Christ Medical Center, Oak Lawn. Applicants: Advocate Health and Hospitals Corporation d/b/a Advocate Christ Medical Center, Advocate Aurora Health, Inc., Advocate Health, Inc. The Applicants propose to add 11 medical/surgical beds to its existing 414 bed complement, resulting in a 425 bed Medical Surgical bed unit. The Hospital is located at 4440 West 95th Street Oak Lawn. Project cost: \$16,194,953.
