1	PROCEEDINGS
2	HEARING OFFICER ROATE: My name is George
3	Roate. I'm, um, accompanied by Mr. John Kniery,
4	administrator, and Mr. Mike Constantino, senior
5	reviewer. We are from the Illinois Department of
6	Public Health, and we represent the Illinois
7	Health Facilities and Service Review Board. We
8	are here to conduct a public hearing on the
9	proposed project known as Project 23-020, DeKalb
10	County Nursing & Rehabilitation DeKalb.
11	As per the rules of the Illinois Health
12	Facilities and Services Review Board, I would like
13	to read a legal notice into record.
14	In accordance with the requirements of the
15	Illinois Health Facilities and Planning Act,
16	notice is given of receipt of application for
17	permit for a change of ownership of DeKalb Nursing
18	and Rehab, 2600 North Annie Glidden Road, DeKalb,
19	Illinois. The applicants are DeKalb Healthcare
20	Holdings, LLC; DeKalb Nursing & Rehab, LLC; DeKalb
21	SNF Land Holdings, LLC; and the County of DeKalb.
22	The purchase price is \$8,300,000.
23	A public hearing will take place pursuant
24	20 ILCS 3960. The public hearing is schedule for

1	Tuesday, July 11th, 2023, at 1:00 p.m. at the
2	DeKalb Police Department, 700 W. Lincoln Highway,
3	Second Floor, DeKalb, Illinois. The public
4	hearing is to be held by the Illinois Department
5	of Public Health pursuant to the Illinois Health
6	Facilities Planning Act. The hearing is open to
7	the public and will afford an opportunity for
8	parties with interest to provide written and/or
9	verbal comment relevant to the project. All
10	allegations and assertions should be relevant to
11	the need for the proposed project and be supported
12	with two copies of documentation, or materials
13	that are printed or typed on paper, sized 8.5 by
14	11 inches. Consideration by the State Board has
15	been tentatively scheduled for July 27th, 2023.
16	That will be the date of the Illinois Health
17	Facilities and Services Review Board meeting. If
18	you have not done so, please sign in using the
19	appropriate registration forms.
20	One form is for the form will allow you
21	to state your position, whether you want to
22	provide as to whether you want to provide
23	testimony in support or opposition to the project.
24	To ensure that the Illinois Health

1	Facilities and Services Review Board's public
2	hearings protect the privacy and maintain the
3	confidentiality of an individual's health
4	information, covered entities, as defined by the
5	Health Insurance Portability Act of 1996, such as
6	facilities, hospital providers, health plans, and
7	healthcare clearinghouses submitting oral or
8	written testimony that discloses protected health
9	information of individuals shall have a valid
10	written authorization from that individual. The
11	authorization shall allow the covered entity to

2	expressed an interest in providing testimony, I
3	must limit each oral presentation to two minutes.
4	I will monitor the time up here, and I will kindly
5	remind you when you hit the two-minute mark.
6	As per the legal notice, I would
7	appreciate two copies of your testimony. When you
8	make your presentation, please give the court
9	reporter the spelling of your complete name. If
10	there is a chief spokesperson for the applicant,
11	we would like that individual to make the first
12	presentation. The remaining testimony will be
13	taken from the order of the forms. Please hold
14	your questions until all testimony is presented.
15	And does anybody have any questions? Then let's
16	begin.
17	UNIDENTIFIED SPEAKER: I have a question.
18	I arrived late I'm sorry due to
19	(indiscernible) situation. Who are the persons
20	identified here as the providers? Are they here?
21	BOARD MEMBER ROATE: Do we have any
22	representation from the prospective buyers?
23	Mr. Silberman?
24	UNIDENTIFIED SPEAKER: And you are from?

2	their behalf.
3	UNIDENTIFIED SPEAKER: Okay. And whom do
4	you represent?
5	MR. SILBERMAN: This isn't the right

7	UNIDENTIFIED SPEAKER: The MA (phonetic),
8	or
9	BOARD MEMBER ROATE: No. In order to
10	proceed with this public hearing, this is giving
11	the public an opportunity. If you would like to
12	ask that question or research that, you are
13	welcome to ask questions at the end of our
14	presentation.
15	UNIDENTIFIED SPEAKER: I'm just curious if
16	the people that are interested in purchasing have
17	representation here.
18	BOARD MEMBER KNIERY: They will have
19	copies of everything that is presented here. We
20	have a court reporter that has all this
21	information, and all of your comments will go to
22	our full Board and the applicant will be made part
23	of the record.
24	UNIDENTIFIED SPEAKER: Thank you.

1	MR. OSTROM: Will that be an open meeting?
2	BOARD MEMBER KNIERY: Yes.
3	UNIDENTIFIED SPEAKER: I have another
4	question. Will you be presenting the description
5	of your decision what is that criteria for
6	what is the decision, and what is the criteria?
7	Will you be describing that to me?
8	BOARD MEMBER ROATE: We are simply taking
9	public testimony in support or opposition of the
10	project. You are welcome to pose we will have
11	an opportunity to pose questions at the end of the
12	public hearing, and you are welcome to readdress
13	that. Okay?
14	UNIDENTIFIED SPEAKER: Thank you. Thank
15	you.
16	MR. OSTROM: Are you here with open mind?
17	BOARD MEMBER ROATE: I'm here I'm a
18	representative of the Illinois Department of
19	Health Facilities and Services.
20	UNIDENTIFIED SPEAKER: I understand that.
21	But are you a nonbiased opinion holder, because I
22	was already told it was cut and dry.
23	BOARD MEMBER ROATE: We are here taking
24	testimony from not only the applicants, but also

1	the general public. We are no side; we have no
2	position in this.
3	MR. OSTROM: But you have to make the
4	recommendation for this sale to go through to Saba
5	with giving them a license?
6	BOARD MEMBER ROATE: I don't, sir. I'm
7	not a board member. We have a nine-person Board
8	that will make this decision based on the
9	testimony that will be presented at the meeting on
10	July 27th.
11	We are non once again, we are we
12	don't hold a position in this matter at all. We
13	are simply a state regulatory agency that accepts
14	the report or the application, reviews the
15	application, and presents the findings to the
16	Board. The Board will make its call on that day.
17	MR. OSTROM: Is that an open meeting also?
18	BOARD MEMBER ROATE: It is an open
19	meeting.
20	UNIDENTIFIED SPEAKER: And this is a
21	colleague of yours, then, from the Illinois
22	Department
23	BOARD MEMBER ROATE: This is my Board
24	administrator, Mr. John Kniery.

1	UNIDENTIFIED SPEAKER: Okay. So, we have
2	no County Board representation here?
3	BOARD MEMBER ROATE: Oh, yeah. We do. We
4	do. For the sake of the time limits, we have
5	almost 40 people registered in attendance. So,
6	what I'd like to do is, if we can get to the
7	testimony, then we can open up at the end after
8	everyone has presented. Once everyone has had a
9	chance to speak, we can open the floor for
10	questions. Is that okay? Okay.
11	To get started, I would like to call Brian
12	Gregory to the podium.
13	MR. GREGORY: Good afternoon, my name is
14	Brian Gregory. Thank you all for being here
15	today. I'm the DeKalb County Administrator, and
16	I'm joined here today by several County Board
17	Members to listen to comments in this matter from
18	the public. The DeKalb County Board and County
19	Administration is absolutely committed to acting
20	in the best public interest of the entire County,
21	and have concluded that this sale is in the best
22	interest of the County.
23	DeKalb County Rehab & Nursing Center has

1	decades, and the County Board administration
2	remains committed to seeing nursing and
3	rehabilitative care be available for the benefit
4	of the current and future County residents for
5	years to come.
6	Toward that end, I want to provide a very
7	brief timeline of the events that leads us to
8	today's certificate of need process. On March 15,
9	2021, the county treasurer, who was appointed in
10	February of '21, informed the County administrator
11	who was appointed March 1st of 2021, that the
12	DCRNC was out of money. If you look back at our
13	audit, it had a net positive position of over
14	\$10 million in 2018. The Board acted very quickly
15	on April 21st, 2021. The County Board voted to
16	approve \$2 million in cash flow assistance to the
17	DCRNC.
18	In October of 2021, in response to the
19	County discussing a planned issue request for
20	proposal for management services, the current
21	management company that had been there for quite
22	some time issued a letter telling us that they
23	were terminating their agreement with the County
24	effective December 31st of that year.

1	November 5th, 2021, receivables were
2	reviewed, and there were approximately
3	\$1.8 million of bad debt to be written off. The
4	majority of the uncollectible receivables are from
5	2018 through 2020, and they were related to
6	Medicaid billing and a failure to file eligibility
7	and claims within prescribed time limits.
8	December 31st, 2021. The DCRNC operating
9	committee is dissolved, and the County Board takes
10	over oversight and governance of DCRNC operations.
11	In April of 2022, the County Board
12	authorizes the sale, transfer, or other
13	disposition of the DeKalb County Rehab & Nursing
14	Center in accordance with Illinois law.
15	In July of 2022, after a total and I'm
16	moving forward briefly in this process, but after
17	a total of 25 public County Board or County Board
18	committee meetings that included agenda items
19	related to financial challenges at the DCRNC, the
20	County at that time had committed \$7.31 million
21	dollars for cash flow purposes. The County Board
22	at that point entered into a letter of intent to
23	sell the DCRNC and accept the offer that was made
24	by Illuminate HC, which was one of two bids

1 submitted. 2 October 19th, 2022. The County Board 3 authorizes the chair, the Board chair, to enter 4 into what's called an asset purchase agreement 5 along with an operational transfer agreement with 6 Illuminate HC, which would operate under LLCs as 7 DeKalb SNF Realty and DeKalb Healthcare Holdings. 8 In April of 2023, the County Board 9 authorized the County administrator to execute 10 this certificate of need application with DeKalb 11 SNF Realty, LLC, and DeKalb Healthcare Holdings, 12 LLC, which is comprised of principals from the Illuminate HC and Saba HC, which is the other 13 company that had submitted a bid. So, principals 14 from both companies came together, and we brought 15 16 it back to the Board for review and approval. 17 (Alarm going off in crowd.) 18 In July of 2023, on July 1st, the County had put a total of \$8,960,000 into cash flow 19 20 assistance for the DCRNC. Throughout the entire 21 process, the Board remained committed to making 22 sure that care was provided to residents at 23 whatever the cost was. And so, that's evidenced 24 by the amount of money that's being put into it.

1	And that takes us today to a public
2	hearing, and then the next step in the process, as
3	we understand it, is the August 15th meeting moved
4	
	to July 27th. That was what was presented to you
5	just a few moments ago.
6	So, today we genuinely express or we thank
7	the public for expressing your views in this
8	matter. We look forward to making a full
9	presentation before the State Board consistent
10	with this certificate of need.
11	BOARD MEMBER ROATE: Sir, I apologize, for
12	the misstatement. The first presentation gives us
13	the whole background. And I apologize, it did run
14	a little over four minutes.
15	Okay. The next person speaking are Dawn
16	Graves. So, you don't wish to speak?
17	MS. GRAVES: No.
18	BOARD MEMBER ROATE: Okay. Thank you.
19	Tom Marsh?
20	MR. MARSH: Pass.
21	BOARD MEMBER ROATE: Pass? Okay. Thank
22	you. Next, Nickie Marsh?
23	MS. MARSH: Yes. I would like to speak.
24	BOARD MEMBER ROATE: Ms. Marsh, please

5	opportunity to speak before everyone. I am
6	speaking here on behalf of my mother, who has been

8	May of 2021, and other residents of the DeKalb
9	County nursing home. She has received excellent
10	care, and we have been very pleased. For the past
11	several weeks, we have been researching Saba, and
12	what we are finding is appalling to say the least.

1	2023, had an abuse report. This facility also
2	noted there were only 15 wash cloths available for
3	their 66 residents. The administrator stated that
4	they are not ordering any wipes because they are
5	only limited to \$500 a month for linen supplies.
6	We would like to say that we are not
7	fighting the County Board on the sale of the
8	nursing home, just the company they are selling
9	to, Saba. However, we are not opposed to them
10	looking at other options, such as the tax levy
11	from 1991. That was never implemented. The Board
12	needs to take a step back and look at the overall
13	the Board needs to take a step back and look
14	into why it was never implemented, and the overall
15	ratings of this facility and company.
16	How in good conscience could any of the
17	Board members have voted yes to a facility that
18	shows abuse and neglect which resulted in the
19	death of one resident and disregard for their
20	general wellbeing. In our research, we have found
21	nine Saba facilities in Illinois have an average
22	of 1.2 stars.
23	In conclusion, we respectfully ask that
24	you review Saba's records while making your

decision. Not reflected by the Board, the
citizens of DeKalb County care a lot about our
elderly population.
BOARD MEMBER ROATE: Thank you, ma'am.
MS. MARSH: Thank you.
BOARD MEMBER ROATE: Next, the Board would
like to call Ken Ostrom. Ostrom, I apologize.
Next, the Board would like to call
Madeleine Nelson. Do you have a form?
Thank you, sir.
MS. NELSON: I'm a 40-year resident of
DeKalb. I have, during my time, heard many
positive comments about DeKalb County nursing home
and rehab center. Residents express how happy
they are to have such a good place to recover from
surgery or place their parents. Knowing DeKalb is
a caring County. We have a 169-year history of
caring for our residents from the original poor
farm in the 1850s to the present county nursing
home. I'm sure that during that time there were
hard times, rough times, health emergencies and
economic stress. But during those times, DeKalb
recognized the need for a safe place for their ill
and elderly. This is not a time to step away from

1	that centuries-old commitment. It is true that
2	the County home has had financial difficulties
3	because of the pandemic. It also appears to be
4	true that there were a number of errors in
5	decisions on the part of the County Board that
6	failed to either redeem, alleviate, or repair the
7	situation. Indeed, County residents the ill,
8	the recovering, and elderly, will be the ones to
9	pay a high price both physically and if the home
10	is sold to the profit company for far less than
11	its value. \$27 million to \$8.5 million.
12	If our entire County and its finances
13	cannot support the County home, a nonprofit, then
14	where is the profit coming from, from the for
15	profit company? Will it come from the cutbacks in
16	staffing, quality of care, or food, as I have read
17	in some IDPH reports? Who expected care after a
18	lifetime of paying this County for the privilege
19	of living here, who now in their time of need are
20	being forgotten.
21	BOARD MEMBER ROATE: The time
22	MS. MARSH: I just have one paragraph. I
23	call for the IDPH to recommend against the sale,
24	and for the County Board to revisit its commitment

1	to our elderly who deserve to be treated with
2	dignity in their later years in a quality and
3	caring nursing home. Would you want your parents
4	in this situation? If not, please say no to the
5	sale. We have because we have been and are a
6	caring County, and we want our nursing home.
7	BOARD MEMBER ROATE: Next, the Board would
8	like to call Melody Benjamin.
9	MS. BENJAMIN: Pass.
10	BOARD MEMBER ROATE: No show?
11	Mike Ostrom?
12	MR. OSTROM: I'd like to know if any of
13	the board members from the DeKalb County who are
14	here. Why don't you stand up so we know who we
15	are talking about and to. Stand up.
16	To each and every one of you have voted to
17	get rid of a building that has taken care of
18	elderly people, because of financing, money, you
19	can find money for everything else, and you can
20	take money from Colby (phonetic), and you can put
21	it towards bridges and towards the police
22	department, but you took it from an amenity that
23	should have gotten it. That's where the shortfall
24	is not where you people are just taking it and

1	putting it where it should be. Why wasn't it
2	taken at the time of 2021 why wasn't that
3	management company that was robbing you blind, and
4	you had to put money into that. But no, you just
5	let them rob you blind until it was all gone.
6	Then you decided to change something. It is now
7	running on its own for the last four months,
8	paying for its own wages. You people haven't had
9	to put anything in that. But you are still hell
10	bent on electing to sell this place just to get
11	rid it because you don't want the financial
12	burden.

3	DeKalb County Operating Board, and the DeKalb

8	put money over human lives. The County has
9	mismanaged and strangled our home financially that
10	we owe such a big debt. Therefore, the best way
11	for the County to correct their mistakes is to put
12	the nursing home up for sale. We understand the
13	place is in a financial hole, but to sell this
14	nursing home to the highest bidder with the worst
15	average star rating is unforgivable.
16	According to IDPH, Saba Healthcare has
17	numerous violations and citations that are very
18	disturbing and jarring. We cannot figure out why
19	the County would do this to our facility. They
20	voted not to sell to Saba Healthcare in the fall
21	of 2022; then this spring, they voted to sell them
22	unanimously voted 22 to nothing. It crosses my
23	mind, did the County Board do their due diligence
24	and do any kind of research on this company that

1	currently has eight underperforming
2	establishments?
3	I did my own research on the facilities
4	and became very upset over the care the residents
5	received. Those people deserved better. Our
6	residents certainly deserve better.

9	elderly becoming a burden on County budgets. But
10	with the right management and hard-working, caring
11	staff, I believe County homes could prosper.
12	In closing, it seems like Saba is not a
13	good fit for our residents. I hope and pray that
14	if your Board agrees to give them the certificate
15	of need, that they keep our high standards and
16	quality of care. We have a longstanding model
17	here at the County home and a history of caring.
18	We deserve to keep making history with a company
19	that cares. Our residents deserve it.
20	BOARD MEMBER ROATE: Next, the Board calls
21	Carolyn Simpson.
22	MS. SIMPSON: I'll pass.
23	BOARD MEMBER ROATE: Diane Tolhurst.
24	MS. TOLHURST: I'll pass.

1	BOARD MEMBER ROATE: Mary Lee Cozad.
2	MS. COZAD: Board member.
3	BOARD MEMBER ROATE: Board member?
4	MS. COZAD: Yeah. Nope. So, I pass. I'm
5	listening to it here.
6	BOARD MEMBER ROATE: Don Gates?
7	MR. GATES: Here, sir.
8	BOARD MEMBER ROATE: Sir, do you wish to
9	speak?
10	MR. GATES: Yes, sir.
11	BOARD MEMBER ROATE: Please approach the
12	podium.
13	MR. GATES: My name is a Don Gates. I
14	reside in Sandwich. I lived in DeKalb County all
15	my life. I had my great grandmother in a nursing
16	home out on 23. I had my mother wind up here as
17	well.
18	First question to this Board, this is a
19	review of permit and everything by the Illinois
20	correct? It's for purchasing this? How come you
21	don't review this company that's got a one-star
22	rating? Sounds like they don't have enough
23	information to handle any more business if they
24	can't handle what they got. I don't know why the

1	State is not revoking the permit. This I don't
2	understand. I would like an explanation on that.
3	Sent to my email. Just a concerned citizen.
4	Another thing about all this is, the
5	County Board is stupid on their money. What
6	people are saying here, there is nothing in their
7	budgets about a million dollars coming back from
8	the courthouse that they borrowed from County home
9	to finish their construction? I asked the
10	question at Board meetings about the tax in '93.
11	Oh, we didn't think we needed it. The number of
12	people on the Board, the whole County voted on it.
13	We said we are for it. They just got rid of the
14	damn thing. That's the most stupidest thing I
15	ever heard. That was the first meeting I was at.
16	They had a nursing home committee. Now
17	maybe they got told when they went into committee
18	for the private stuff. But there was no record of
19	any budgets or anything about that County nursing
20	home facts until late, and then it disappeared.
21	They just hired somebody to pay them \$10,000 a
22	month or better to run something and never looked
23	to see what they are doing. They were told by a
24	former administrator not to build the addition.

1	From what I understand, that addition cost
2	\$13 million. They are selling it for \$8 million,
3	plus an \$8 million mortgage is that correct
4	for a total of \$16 million? That was bottom on
5	your pages on the application?
6	Is that correct, sir?
7	BOARD MEMBER CONSTANTINO: The application
8	says the purchase price is \$8,300,000.
9	MR. GATES: They don't have to assume a
10	mortgage of \$8 million?
11	BOARD MEMBER ROATE: I haven't read that.
12	BOARD MEMBER CONSTANTINO: Cash is
13	\$750,000, and the mortgage for the balance.
14	MR. GATES: The mortgage is \$8 million?
15	BOARD MEMBER CONSTANTINO: No
16	MR. GATES: Well, no, the company is
17	getting the mortgage? What about the mortgage for
18	the addition? Did the County pay for that?
19	BOARD MEMBER CONSTANTINO: Not that we are
20	aware of.
21	MR. GATZ: So, we are selling a building
22	for pennies on the dollar. You know, you got a
23	\$25 million thing, and the goddamn place is going
24	for pennies. And the voters should be concerned.

1	The lawyer and the County is footing the damn
2	taxes and everything else. It's nice to see when
3	they dig a shovel in the ground and say, Oh, this
4	is nice. But is everything falling down?
5	I don't understand it. It just makes me
6	furious. Another thing the County Board told me
7	is that the assisted living building out there is
8	built on the county line, which all that was
9	bought by the nursing home from the farmers. The
10	County robbed that money. But they pay a dollar
11	per year for rent. I was told by the last
12	Chairman, John Frieders, that \$3- to \$600,000
13	would would come back into the nursing home from
14	that thing. I can't find it in the budget where
15	any additional income came.
16	All I say, there is more wrong than the
17	State issuing a permit to somebody that can't run
18	a building. And the way our County has managed
19	its building. I'm sorry. There is more.
20	The County home is the only nursing home
21	you can go into, you will not smell urine. That's
22	your first testimony.
23	BOARD MEMBER ROATE: Next, the State Board
24	would like to call Tillie Mackey.

2	to know if you want to speak.
3	BOARD MEMBER ROATE: Tillie, if you would
4	like to speak from where you are sitting, that's
5	fine.

8	BOARD MEMBER ROATE: We haven't gotten
9	cordless mics. I can come back and revisit. We

14	Moving on. Charles Simpson?
15	MR. SIMPSON: Well, I'm going to make this
16	short and sweet. Of this home, I am trying the

18	better deal than what they are getting, and I
19	blame the Board that sits on here and allows this
20	nursing home to go into the hole and not doing a
21	damn thing about it sitting there now, they
22	want to bail themselves out by selling it.
23	This ain't fair to the old people out
24	here. I am old myself; I am 80 years old. These

2	They shouldn't even be here. They should be
3	fired. They are not for this. They don't want to

5	This place has been a nursing home for
6	about a 150 years, and they get a Board in here,

7	know what four stars looks like.
8	First of all, just let me say, I don't
9	think the Board did their due diligence in
10	exploring all the options that you could possibly
11	use to keep this going in the County. Have you
12	looked at partnerships? DeKalb County has huge
13	resources of mega companies like 3M, you know, all
14	these new guys Facebook. They are all looking
15	to partnership with the County.
16	Why don't we look at using them? Why not,
17	instead of having the County Board members run the
18	place, why don't we elect a board of governors?
19	They are not business people; they are
20	politicians. Let's get the people who are
21	interested in the needs of this building. And I
22	guess that's all I have to say.
23	BOARD MEMBER ROATE: Thank you. Next, the
24	Board would like to call Gayle Hawkins.

1	MS. HAWKINS: I pass.
2	BOARD MEMBER ROATE: Pass? Gary Hawkins?
3	MR. HAWKINS: I pass.
4	BOARD MEMBER ROATE: Brother El-Jamal?
5	UNIDENTIFIED SPEAKER: Can we get the mic
6	here?
7	MR. EL-JAMAL: I'm in a wheelchair.
8	BOARD MEMBER ROATE: Mr. Jamal, if you
9	don't mind, I'll see if we can find a cordless
10	microphone for both of you.
11	BOARD MEMBER ROATE: Next, the Board would
12	like to call Carol Deemer.
13	MS. DEEMER: My body hasn't figured out
14	I'm upright. So, be patient. I get there
15	eventually.
16	BOARD MEMBER ROATE: That's fine.
17	MS. DEEMER: Can I just say, that's not
18	part of my two minutes, is that I have never said
19	anything in two minutes in my life. So, good
20	luck.
21	My name is a Carol Deemer. I have lived
22	in DeKalb for 56 years. My mother was born and
23	raised here. She was a Lambert on the Lambert
24	homestead on Nelson Road, where my cousin still

1	farms. My grandparents both used the facilities
2	many years ago, from DeKalb County.
3	I'm here as a representative of the
4	community, because I've been part of it for so

8	as the group to run the nursing home.
9	(Phone alarm going off.)
10	So, that's really the focus that I have.
11	DeKalb County Nursing & Rehab Center is a resource
12	for residents of DeKalb County for rehab and
13	nursing care, both long-term, short-term. People
14	come there, they are well-cared for, and the
15	reputation has always been excellent. I would
16	like to present my objections to the County home
17	sale to Saba.
18	In my experience, past performance is an
19	excellent forecaster for future performance. If
20	there is a new facility owned by Saba, I see no
21	reason why I wouldn't believe that they are going
22	to do the same thing as they have done in their
23	other one-star places.
24	Mr. Blonder and Mr. Singer both have

1	significant ownership in ten not eight as it
2	was put on paperwork but ten nursing homes in
3	Illinois. I have gone through and read every word
4	of all the surveys done by IDPH for lack of
5	compliance to policies of both Saba nursing homes
6	and the policy of IDPH and the Department of
7	Aging. I analyzed the surveys, and two things
8	became clear. Number one, that there is a pattern
9	that happens over and over in the same facilities,
10	and across Saba facilities, and I thought it was
11	important to see that those kind of things
12	continue to happen. These patterns of behavior
13	indicate similar problems will probably result at
14	DCRNC after the sale to Saba.
15	The other thing I did was identify quite a
16	number of really egregious, egregious findings of
17	things that have happened in Saba nursing homes
18	that are horrible, horrible, and horrifying. They
19	have a real lack of concern for residents who make
20	their home in a Saba facility. People who have
21	disabilities, both mental and physical, who are
22	aged, who are unable to care for themselves, who
23	have no one able to care for them, deserve to live
24	in dignity and receive respect from the facility

1	administrators, from staff, and the owners.
2	These are not throw away people who are
3	cash cows for owners who put profit ahead of
4	responsibility to ensure quality care for those
5	who are in who are making their home in the
6	facility.
7	Patterns. Because I only have two or
8	three minutes
9	BOARD MEMBER KNIERY: You are at three
10	minutes.
11	MS. DEEMER: Thank you. I have a whole
12	page to throw away. I would just like to just
13	say, these are the patterns that I found as I
14	looked across every every one of the nursing
15	homes that Saba owns.
16	Okay. The first one is ADL. This is an
17	abbreviation for activities of daily living, and
18	it is what many residents are unable to do for
19	themselves. They are simple things like getting
20	dressed, taking a shower, getting their nails
21	trimmed, help with toileting, help with eating.
22	So, these are things that are often not well
23	handled in many of the Saba nursing homes. So,
24	this is a deficiency that is a pattern across the

1	board.
2	The second one is abuse. There are
3	unfortunately times when there is abuse resident
4	to resident, staff to resident, resident to staff.
5	It is important that every one who is in the
6	nursing home feel safe. If you cannot control the
7	people that are going to be causing these kinds of
8	difficulties, maybe those are not the people you
9	need to be bringing into the home.
10	For instance, one place did not do a
11	background check, hired a convicted sex offender
12	who then performed a sex act on one of the
13	residents. So, that kind of abuse really has to
14	be considered as we are looking forward.
15	(Phone going off.)
16	UNIDENTIFIED SPEAKER: That's okay. Let
17	her talk. There is ten people out here. So,
18	she's fine.
19	MS. DEEMER: I read the stuff. So, I'm
20	right there for you. Housekeeping can be a
21	problem in many of these places. One of the most
22	severe is hygiene and handwashing, that people go
23	from one patient to another. They changed a
24	person who is incontinent; they are wearing

1	gloves. If they don't take the gloves off, you
2	know, in kindergarten, we learn how to wash our
3	hands.
4	So, that's part of what that was one of
5	them that keeps coming up. Incontinence care can
6	be a real problem. In some of the facilities,
7	maintenance is really a problem. But not in a
8	lot; just in a few.
9	There is a history across the board of
10	medicine errors. This could be not making sure
11	that the person is actually taking the medicine.
12	They have no proof to taking it themselves. But
13	it's just put down on their bedside table. Some
14	of the medications have been expired. Sometimes
15	they run out, and those type of things really need
16	to be looked at in terms of keeping people
17	healthy.
18	And shortage of staff is probably the
19	biggest that I see over and over again, and I
20	think probably makes probably lots of these
21	problems exist, because there are not enough
22	people to take care of everybody. And the last
23	thing they had was wound care, and that's when,
24	um, wounds come lots of people have diabetes,

1	there are times when skin shreds, and they really
2	have to watch that.
3	BOARD MEMBER ROATE: Your time is
4	MS. DEEMER: And I will do that. I will
5	leave a whole page out. But I am going to present
6	my letter
7	BOARD MEMBER ROATE: Thank you.
8	MS. DEEMER: with an addendum with the
9	information on here that I found from the survey.
10	Thank you.
11	BOARD MEMBER ROATE: Thank you. Next, the
12	State Board would like the call Kathy Burright.
13	MS. BURRIGHT: I pass.
14	BOARD MEMBER ROATE: Montez Soliz.
15	MR. SOLIZ: Pass.
16	BOARD MEMBER ROATE: Pass? Cheryl LaRosa?
17	MS. LAROSA: I pass, but stand by my
18	well-spoken friends for sure.
19	UNIDENTIFIED SPEAKER: Forgive me, I'm
20	looking for a microphone.
21	BOARD MEMBER ROATE: Thank you.
22	In the meantime, the State would like to
23	call Mark LaRosa.
24	MR. LAROSA: No comment.

2	Kathleen Perilongo?
3	MS. PERILONGO: So, I'm a 40-year
4	employee, retired employee, of the nursing home.
5	Five years a volunteer during COVID. In the early
6	'90s, I headed up quite a few committees to get
7	the nursing home on the ballot to save it.
8	And my only concern is, why did it not go
9	on the ballot to let the taxpayers and the voters
10	of DeKalb County decide what to do with our
11	nursing home?
12	And it was only fair that we decide, not

1	MS. HENKE: I pass.
2	BOARD MEMBER ROATE: Scott Campbell?
3	MR. CAMPBELL: I pass.
4	BOARD MEMBER ROATE: Nancy Dashner?
5	MS. DASHNER: Can you see me back there?
6	I am Nancy Dashner. I'm a 34-year
7	resident of DeKalb County, and I am here in
8	opposition of sale, period, in that I voiced my
9	concerns on the 10th of January to my County Board
10	member and did not even get the courtesy of a
11	reply. So, I'm very concerned about that. They
12	should be responsive to those of us who are
13	funding them.
14	They also I'd like to reiterate what a
15	previous speaker just said, Why are we the ones
16	who are paying for all this, not given the choice
17	of a referendum? Was the Board concerned that we
18	would vote yes, as we did the last time, when they
19	thought it would go down and it did not? Are we
20	concerned that people who would want this facility
21	and they do not? Who is actually funding this
22	them or us? That is my comment.
23	BOARD MEMBER ROATE: Next, the Board would
24	like to call RuKisha Crawford. RuKisha?

1	MS. CRAWFORD: Good evening, everyone. My
2	name is a RuKisha Crawford, and I am here with my
3	community. I am a Board member. I chair the HHS
4	committee, um, and I just would like to say I am
5	in support, and I have also been in support of my
6	residents.
7	When I ran for election, I ran to be your
8	voice, and I'm here today to be your voice in
9	support of you. So, I just want to say thank you
10	for your time, and thank you for this hearing, and
11	thank you for your backing.

14	MR. KAPITAN: I don't have a relative to
15	the county home, but I have always had confidence

19	services someday. I'm concerned about
20	transferring ownership to a substandard company.
21	I believe that the sale should be rejected for
22	this substandard quality. It's my understanding
23	that the County Board rejected one of the bids
24	because of the company's poor quality rating. And

2	agreeing to the sale, the newly-formed LLC from
3	the company that's one of the sleight of hands

7	found that the Board on this new LLC had changed
8	to include people from the rejected poor quality
9	company. The County Board was advised that they
10	would be in breach of contract if they rejected
11	the sale at that point.

14	recommendation, a breach of contract, to ratify it
15	with the new LLC.
16	Please reject this company, the sale to

11	Board would like to call Lori Ireton.
12	MS. IRETON: Well, I came here, but I
13	didn't anticipate to talk. I'm good. I was born
14	in Sycamore in 1959. So, I challenge any County
15	Board member to know the history of what this
16	building this facility has. I started at the
17	old facility in 1989. We went through the
18	referendum. We went through the sale, on which
19	the County Board never gave the county home any of
20	the money that was owned by the county farm.
21	And the county farm, it was and it was
22	designated to take care of our people. They took
23	the money; they went and they created a building
24	commission. That building commission, Mr. Bob

1	Hutchinson, who has built this building with
2	ownership to DeKalb County, not the nursing home.
3	The nursing home had to go into an agreement to
4	pay rent. We paid a monthly fee to the County
5	Board every month. We didn't own that building.
6	We never got any money from the sale of our farm.
7	So, as 27 years in social work admissions,
8	I retired on June 30th, 2017. I did admissions, I
9	did social work; I worked seven days a week, as
10	you make that commitment when you go into
11	long-term care.
12	On May 9th, 2017, I hand wrote, hand
13	wrote, a letter because Mike Scavatto always made
14	a comment he's the dude from St. Louis that
15	if you do email, guess what, there is a paper
16	trail that will always come to haunt you.
17	Well, I wrote to Gary Hanson, who was the
18	County Administrator at that time, and got a
19	letter to him, to his secretary, who happened to
20	be Tasha Sims at the time, with a copy of that
21	letter, addressed to everyone of the County Board
22	members. It addressed all the issues that this
23	company in St. Louis was doing had occurred in
24	this building. Not one person responded to me

7	retired. I should have gave them the benefit of

12	facility sits three quarters empty right now.
13	I have my dad there for the fourth time.
14	This time permanently. The only savior that I
15	have is I walk into that building and find so many
16	of my coworkers still there. So many of them
17	still giving the hugs, the love, embracing the
18	families, understanding where families come from.
19	And I know, because I listened to many families.
20	There is nothing perfect. It's not one-on-one
21	care. But man, we can make it a lot better and we
22	can solve problems. The County Board has done a
23	huge disservice to this community. A huge
24	disservice.

1	The only thing I ask, and I know the cycle
2	of the County Board goes round and round
3	(Phone alert going off.)
4	MS. IRETON: and round, but you know,
5	but we were a 4- and 5-star facility. And you
6	need to know that, that there are people out
7	there. There has been people back there that have
8	tried to run things, and we know how to do that
9	job. You just got to get the right people in
10	there to do it.
11	BOARD MEMBER ROATE: Thank you.
12	Next, the Board would like to call
13	Dorianne Burg.
14	MS. BURG: I'm Dori Burg. With any luck,
15	I'll be 75 next year. I'm a grandmother. Thank

19	home up on Annie Glidden no, up on Sycamore
20	Road, and we would entertain and we would play
21	music. We would sing songs. She would play the
22	accordion, I would play guitar, and we would bring
23	the bells for the residents. I went with my good
24	friends Paula Hobson, Dr. Hobson. She and I were

16	I come here today to ask you to deny this
17	request. The basis of denial should be that the
18	sale, at least financially, that the sale price is
19	not enough. It does not reflect their value of
20	the assets being sold. This sale is not a fair
21	transaction.
22	Just a few years ago, this very Health
23	Facilities and Services Review Board approved the
24	addition the addition to the nursing home at a

Г

1	cost of \$13 million. How can a building addition
2	of \$13 million, plus the existing nursing home
3	constructed less than 25 years ago, plus the land
4	at an attractive intersection in the City of
5	DeKalb now only be worth \$8.3 million?
6	At this point, only this Board only
7	this Board can protect the financial interests of
8	DeKalb County taxpayers. You need to deny this
9	request. As a result of denial, it means that the
10	deal will not sell the taxpayers short. It means
11	that not just 24 members of our hardworking County
12	Board will not sell out the taxpayers. It means
13	that a referendum could still be held, and that
14	65,000 voters could make a decision about the
15	sale. The people who own this facility should be
16	able to decide. Letting the citizens have a voice
17	is in your hands. From a human standpoint, what
18	is at stake? Have you never seen deplorable
19	conditions in a nursing home? Can you imagine it?
20	You have read it; you have seen it; we know it
21	exists. And what is at stake? What is at stake?
22	The mentor that took care of us will be
23	assigned to a deplorable place. The teacher that
24	spent additional time with us will go there and

1	not be taken care of. The parent who took care of
2	us when we could not take care of ourselves will
3	be sent there to not be taken care of. We have
4	all been taught as citizens of our country to care
5	for our elders. Here is the pivotal moment, and
6	it's a pivotal moment of good government.
7	There can be good government. It can be
8	hard, but we can do this. The commonwealth that
9	we exist in means the commonwealth means the
10	wealth of all. It means we must care for each
11	other.
12	We have a duty of care here. Please give
13	us another chance. Press pause on this, and give
14	us a chance as all citizens to take care of this
15	matter on our own. Thank you for the time to
16	speak.
17	BOARD MEMBER ROATE: I'd like to apologize
18	up front because I don't think we are going to be
19	able to get handheld microphones. However, I
20	would like these individuals to at least have an
21	opportunity to speak. I would like to ask the
22	court reporter if you can hear, or if you are
23	having trouble hearing, please let us know. Okay?
24	Okay. Ms. Roman, are you ready to speak?

1	MS. ROMAN: Yes. I am, sir.
2	I will, on this Tuesday, July 11th, 2023.
3	This is in regards to the DeKalb County nursing
4	home hearing 23-024. Good afternoon to all the
5	people who are here today.
6	HellO. My name is Mary Roman, and I am a
7	resident of the DeKalb County Rehab & Nursing
8	Center. My daughter and I visited many nursing
9	facilities in Northern Illinois to find a good
10	nursing home for me to live. We finally came upon
11	the DeKalb County home. The County home has been
12	serving the DeKalb County area for close to
13	170 years, with some staff members currently
14	working there for 25- to 40-plus years. We
15	decided it was the best option we had. I do not
16	want to live in a facility where I am
17	uncomfortable and have to live in fear. I have
18	not felt that way living in the DeKalb County home
19	since I have been living here for the past eight
20	years. I really would like to keep it that way.
21	There are no facilities perfect in the area or
22	anywhere.
23	I would say that when my nursing home sees
24	or hears of a complaint or problem, our

1	administrator works quickly to resolve the issues.
2	Please do not give Saba Healthcare our operating
3	license. We do not want to have them take over
4	our facility. Saba has numerous state-documented
5	violations. Many of these violations have
6	resulted in serious taxes and heavy fines.
7	Currently, they have 170 citations various
8	unsatisfactory nursing operations. We have been
9	presented and read some of the more disturbing
10	violations, and frankly, it has a lot of residents
11	scared that might happen here.
12	In closing, again, please do not give Saba
13	Health Care our operating license. We love our
14	home just the way it is. We pray that you
15	consider our pleas not to give them our home. By
16	making your final decision, please keep our
17	nursing home family in our prayers.
18	And I added something that I thought of
19	last night. As I couldn't sleep, I started
20	thinking, and I thought, would you ever think of
21	putting your loved one in a home like that? No.
22	No. I wouldn't. Never ever think of putting my
23	loved one in a home like that in their final days
24	of living.

1	Thank you, and I thank you for letting me
2	have this time. Mary Roman, a very concerned
3	resident.
4	BOARD MEMBER ROATE: Thank you.
5	Next, the board would like to call Brother
6	El-Jamal.
7	MR. EL-JAMAL: Yes. Saba has developed a
8	diagram of mismanagement for the nursing homes.
9	Not just one, but several. It seems to have been
10	constructed that way on purpose. Illinois
11	Department of Public Health made recommendations
12	to assist Saba to correct the problems, and those
13	problems are solved, but only temporarily.
14	Clearly, they have continued to manage
15	their properties in the exact same way so they
16	continue to recur. Some of the problems have been
17	addressed in the surveys are likely to appear in
18	the DeKalb County Rehab & Nursing Center if Saba
19	purchases the property. Residents are aware of
20	Saba's reputation for ownership. Many are 1-star
21	facilities. This has created a great deal of
22	anxiety because residents are afraid that the
23	nursing home will become so unlivable that they
24	will suffer under Saba's management. There is no

1	indication that their management style will
2	change.
3	BOARD MEMBER ROATE: Thank you. Thank
4	you, sir. Next, the Board would like to call
5	Tillie Mackey.
6	MS. MACKEY: As I said, I am Tillie
7	Mackey. I've been a resident of the DeKalb County
8	home for a little over five years. We moved out
9	here in the '80s, and one of my sons had this
10	girlfriend who was planning on being a nurse. She
11	didn't fulfill her promise. But she told me back
12	in the '80s that of all the nursing homes, DeKalb
13	County was number one on the list. Well, never
14	did I ever think I would end up here, but here I
15	am. And we can't go back; what's done is done.
16	But I really feel the Board, if I know or think I
17	know what was said, they were supposed to put
18	something on the ballots to have the people want
19	to pay an extra tax for the money to go to the
20	nursing home. But I guess it never got to get on
21	the ballots, and I really feel hurt. I'm not that
22	knowledgeable about financial things, but I think
23	maybe if the County Board at least gave us a
24	chance. You called us out before we even got up

1	to bat, and I think that's a shame. And I say
2	shame, shame on you. You are not thinking ahead.
3	You are never going to be 40 years old. You are
4	going to end up like me, 92 years old, and here I
5	am still kicking and complaining.
6	(Phone alert going off.)
7	MS. MACKEY: I'm sorry. But if I see
8	something, I say something. I see a lot of things
9	that I shouldn't see, and like I say, you can't
10	change what happened, but we can correct it now.
11	And please keep our own number one on the list.
12	BOARD MEMBER ROATE: Thank you, Tillie.
13	Next, the Board would like to call Magdalen Niemi.
14	MS. NIEMI: My name is Magdalen Niemi.
15	I'm a concerned citizen. I've been a nurse for
16	40-some years. I have worked here for over ten
17	years. I worked there in 1988 and '89. I became
18	a nurse at 19. So, I have worked in long-term
19	care for 22 years. As a nurse, I became a nursing
20	instructor after I left DeKalb County, and we
21	teach the nurses the nursing process. There is
22	assessment, data collection, diagnosis,
23	interventions, and evaluations. There is also
24	nurses take an oath to do no harm.

Г

1	Now, I have spent a lot of time on this
2	issue, because I worked hard when I was in the
3	position as the administrator there. I was there
4	for 11 short months. When I started there in
5	October, the MPA management company was there, and
6	the previous administrator left. But no one told
7	me that they didn't pay pills for four months.
8	Now, the process I understand is those bills are
9	given to the County Board for approval before it's
10	paid out. So, they were well aware of situation.
11	MPA managed the company for 24 years.
12	In January, when Giovanni (phonetic) was
13	hired as a consultant, I did research. He was the
14	number one retail broker for commercial real
15	estate in the country. The number one broker.
16	So, his interest was to sell the nursing home, not
17	to look at the other options. He got \$10,000 to
18	be a consultant. But how could he be a consultant
19	when he was affiliated with a real estate company,
20	a commercial real estate company? And so, he gave
21	options of a management company, a sale, or a
22	leasing. But I feel that that information wasn't
23	accurate. I don't feel the information that the
24	Board got from MPA was accurate.

Г

1	MPA does have a record. They managed the
2	County nursing home in Champaign. Okay. That was
3	sold to a family of the Rothner family. Okay?
4	Flash forward to July of last year, Saba,
5	at our County Board meeting, and Shaw reported him
6	as saying that he did have investments with the
7	Rothner family. Two months ago, the Illinois news
8	in Champaign covered a story about this. The
9	county nursing home was bought by the Rothner
10	family, and they promised the County Board that
11	they would not they would keep it a nursing
12	home for at least five years. Two months ago,
13	they are going to be selling the nursing home.
14	And the article you can read it I
15	did give this information to the Board this
16	morning, the articles that I found in the links.
17	And they have bought a couple other nursing homes
18	in the counties in the community around
19	Champaign, and they have also been closing.
20	So, MPA, I think was a predator company
21	looking, because they looked at Rock Island County
22	nursing home. They managed it. Also, at
23	Champaign, it was interesting because when MPA was
24	managing that, they had a big addition built

Г

1	millions of dollars for the addition that was
2	built. Well, I don't know if the proper bidding
3	was done at the time, but the management company
4	MPA that was hired built the nursing home, Mike
5	Scavatto, they were hired to manage the project.
6	So, I think they got money right off the top, and
7	they built an addition onto the nursing home in
8	Champaign, and at Rock County Rock Island. I'm
9	not sure. But there was a pattern of MPA going to
10	county nursing homes and for whatever reason,
11	taking on a huge amount of debt.
12	Now, I think Ms. Willis (phonetic) was
13	recorded on TV recently saying that the debt was
14	from 2021. Well, that was two years ago. So, if
15	the accumulation of debt occurred in 2021 and
16	during that time, I feel that there wasn't an
17	accurate budget. So, even with the certificate of
18	need application, I do have a concern, because my
19	understanding, like, as we speak now, the DeKalb
20	County Rehab & Nursing Center does not have a
21	budget.
22	Now, they had a budget in 2022 that in
23	2023 had to be amended to remove the money that
24	they had put into the budget for the sale of the

1	nursing home because it didn't happen. Now, they
2	did have a budget because I was following this.
3	I was very interested in this, and I was following
4	this, because in July of 2022, if there was a dire
5	need of financial hardship for the County, and I
6	heard if the nursing home wasn't going to be sold,
7	then the 17 other departments at the county level
8	will be suffering.
9	So, I was expecting big news. And I was
10	following it, and I didn't hear of anything. I
11	didn't hear any reports of the county nursing home
12	needing money, any jeopardy of any other
13	departments losing their buildings (indiscernible)
14	car.
15	BOARD MEMBER ROATE: Thank you.
16	MS. NIEMI: I didn't hear that. So, my
17	concern is, please do not sell it to Saba. And I
18	want to say, finally, in July, Mitch Saba had said
19	to the County Board that he does not believe in
20	the star rating because it doesn't deliver due
21	process. My question is, is he giving the
22	patients at his nursing home due process when he
23	decides not to buy linens? I don't think that's
24	due process.

Г

1	Please do not sell it to Saba. Please
2	evaluate how it can be self-sustaining, and I
3	would like to have a recommendation that is there
4	is a County Board committee developed again for
5	the nursing home, because it is reliable, and in
6	the certificate of need application, it says that
7	if the sale does doesn't go through, then the
8	nursing home will have to be closed. I don't
9	agree with that application statement, because I
10	don't think the nursing home should have to be
11	closed if there is no sale. Thank you.
12	BOARD MEMBER ROATE: Thank you. And the
13	Board would like to call Cindy Kozumplik,
14	MS. KOZUMPLIK: Kozumplik.
15	BOARD MEMBER ROATE: Sorry about that.
16	MS. KOZUMPLIK: Good afternoon. I am not
17	going to talk about past financial information
18	because my parents were not at the facility during
19	all the time of hardship. So, I'm not going to
20	address any of that. What I would like the Board
21	to consider where it's going in the future. The
22	facility is making money over the last couple
23	months, as I have been made aware. I have had
24	both of my parents at the facility. I had one of

1	my parents in another facility before we went to
2	the County home. In that time period, which is
3	about a month, one of my parents fell like four
4	different times at that previous facility. Since
5	that parent has now been at the County home, their
6	care is getting much better. There are people
7	watching them. There are people looking out for
8	them. The staff has cared for both of my parents.
9	There are regular activities going on, and the
10	staff the County home even cares about the
11	needs of us as family members. Within the
12	dementia unit, which is where one of my parents is
13	at, we have monthly support meetings to care about
14	the needs of us. We are not the regular
15	caregivers, but we are still caregivers to our
16	family. It would very much hurt me and my family
17	members to have this facility go to somebody else
18	who is not going to care for them the way they do
19	in the dementia unit. I can't speak a hundred
20	percent of the other units, but I've had parents
21	in both sides, and I do see the care that is
22	given. They care, they question, they come up to
23	you and say, Are you doing okay today? And that's
24	just me coming in and out, spending anywhere from

1	20 minutes to 2 hours visiting them. I'm not
2	there 24/7. I don't believe, with everything that
3	I've heard and I've seen of the care at the
4	facility, that Saba is the best choice for DeKalb
5	County. Thank you.
6	BOARD MEMBER ROATE: The Board would like
7	to call Mark Silberman.
8	BOARD MEMBER ROATE: Is there anybody else
9	who would like to speak who has not had an
10	opportunity to do so?
11	UNIDENTIFIED SPEAKER: No, thank you. I
12	would I have to turn this on.
13	MR. OSTROM: Is he going to get more than
14	two minutes?
15	BOARD MEMBER KNIERY: Sir, everyone in
16	here has gotten more than two minutes.
17	MR. OSTROM: Seems like you
18	(indiscernible) extra time.
19	BOARD MEMBER ROATE: And I give you plenty
20	of time. I gave you more than five minutes.
21	MR. OSTROM: I wasn't even hoarse.
22	MR. SILBERMAN: Good afternoon, everyone.
23	My name is Mark Silberman, and I want to start by
24	thanking everyone for coming out and participating

1	today. And I want to include specifically the
2	residents that came out. I want to include the
3	members of the community, and I want to include
4	everybody who both spoke and those who are just
5	here to support and are concerned enough.
6	One thing I just want to acknowledge,
7	generally, with regards to the state of affairs in
8	long-term care in Illinois, one of the significant
9	challenges that county facilities has had has been
10	the apathy of the communities, and that is clearly
11	not the case here. That is clearly not evident,
12	and I think the fact that you have so many people
13	so passionately involved is also going to yield
14	the long-term success of this facility, regardless
15	of what path goes forward. And I want to start by
16	saying that I cannot speak, and it wouldn't be my
17	place to speak, to anything in the past. But we
18	are looking forward to the process ahead and to
19	the future, and to continued access to care is
20	very important and is key to this project.
21	The purchase of this facility, which is
22	DeKalb Healthcare Holdings, are very excited at
23	the prospects of owning and operating this
24	facility, and the purpose of them buying the

Г

1	facility is to continue to operate it so that
2	DeKalb residents continue to have access to a
3	facility. Because while I can't speak to the
4	County and to the County's finances, there is the
5	very real responsibility that absent a transaction
6	like this, the facility could close. And I think
7	the worst thing would be lack of access to a
8	facility.
9	Now, much has been made of the star rating
10	of other facilities, and I am not going to get
11	into the specifics, but I just want to ask members
12	of the public to keep an open mind with the
13	following thing: That issues have been raised
14	with regard to a business that is owning and
15	operating one-star facilities. But it is a
16	business that has made practice of acquiring
17	existing, struggling one-star facilities, and then
18	continuing to stabilize and operate them towards
19	the long-term goal of improvement.
20	And the reason I raise that is, you will
21	not find evidence of buying the high-performing
22	facilities that they have all used the vernacular,
23	run into the ground. And that isn't to make light
24	of any incident. That isn't to make light of any

1	violations, just a touch of credibility. I'm the
2	former Deputy General counsel for the Illinois
3	Department of Public Health. I was in charge of
4	all licensing and enforcement for the State of
5	Illinois. So, I promise you
6	(Phone alert goes off.)
7	MR. SILBERMAN: I have seen anything
8	and everything that violations have to offer. One
9	thing that I also want to point out is this: This
10	is not a struggling facility that is a one-star
11	facility. I want to acknowledge the point that, I
12	believe, Mr. Simpson, I believe Chuck, I
13	believe there were two Mr. Simpsons raised
14	this. This is a facility that has an existing and
15	dedicated staff, and that is a fundamentally
16	important and significant factor.
17	What I want you to consider when you look
18	at the history of the owners is the following:
19	These owners have demonstrated what it is to work
20	with and learn from existing staff; to invest
21	funds necessary to allow for both the maintenance
22	of but also improvement of the facility. When you
23	look at their facilities, these aren't facilities
24	that get bought and then closed. They continue to

Г

1	own them and continue to operate them, and that
2	their commitment to both the operation of this
3	facility in DeKalb, but also to successfully
4	returning it to the stability and the previous
5	level of success that it previously enjoyed, to
6	ensure that DeKalb County will continue to have
7	access to this necessary care. Again, I
8	UNIDENTIFIED SPEAKER: I agree.
9	MR. SILBERMAN: You know, you are entitled
10	to your opinions, but
11	I want to thank everyone for taking the
12	time to come out here. I want to assure you that
13	not only will the Board be taking into
14	consideration the public comments that were made
15	today, but so will we.
16	MR. OSTROM: Do we ask any questions to
17	you?
18	MR. SILBERMAN: That is not this process.
19	So
20	MR. OSTROM: Of course, you don't want to
21	to be asked questions that you can't answer and
22	aren't going to answer truthfully. Why would you?
23	MR. SILBERMAN: I will only state that as
24	a former general counsel of this Board 20 years

1	ago, I respect their process, and I'm not going to
2	act outside.
3	UNIDENTIFIED SPEAKER: I do have one
4	question I just wanted to have reiterated to me.
5	You or somebody said that the Board was
6	selling to Saba for \$8.3 million, but only
7	\$700,000 of it had to be cash, and the rest was
8	just taking over their mortgage? Is that correct?
9	Is that how I understood that?
10	BOARD MEMBER CONSTANTINO: That was the
11	information that was provided to us.
12	MR. OSTROM: Wouldn't the administrator be
13	able to tell us?
14	BOARD MEMBER KNIERY: \$750,000 in cash and
15	a mortgage for the remainder.
16	MR. OSTROM: So, they are only getting
17	\$750,000 for it? They are just taking over the
18	loan.
19	BOARD MEMBER CONSTANTINO: The mortgage is
20	to risk with another entity, not with the County.
21	MR. OSTROM: So, the County will get
22	\$8.3 million.
23	MR. OSTROM: So, what is this going to do?
24	UNIDENTIFIED SPEAKER: Well, it looks like

1	they have blown everything off.
2	MR. OSTROM: Can you reiterate what other
3	projects you got going on that you want to
4	BOARD MEMBER ROATE: For the sake of
5	moving forward with this formal process, is there
6	anyone who wishes to testify who has not had an
7	opportunity?
8	Seeing none, is there anyone who wishes to
9	testify who wishes to provide additional
10	testimony? Sir? Please approach the podium.
11	And if you would, please give the court
12	reporter your name.
13	MR. DUCHROW: I don't have it. I'm sorry.
14	I am Steven Duchrow.
15	BOARD MEMBER CONSTANTINO: Can you spell
16	that, Steven?
17	MR. DUCHROW: D-u-c-h-r-o-w.
18	I still don't know what I'm going to say.
19	I'm going to, but I am going to try to speak from
20	my heart. If it's been said once, it's been said
21	a million times that people feel government
22	doesn't work. I don't agree with that. I think
23	good government, given a chance, can work, and it
24	does work. We all complain about times that

Г

1	when it doesn't work, and here is an opportunity
2	where we have a chance to make it work. We all
3	believe in civic participation, that citizens get
4	an opportunity to have a voice. We had 24 people
5	that made a decision, and we have 65,000 that
6	should be allowed that opportunity. There is
7	something sacred here that is at stake. It just
8	isn't a financial transaction. It's the people
9	that we stood at a marriage altar and said, I will
10	care for you. It's parents who take care of us
11	and said, I will care for you. That's a sacred
12	oath. Civic participation is a sacred oath. We
13	should be allowed that opportunity to rectify it
14	if we made a mistake. We should have that
15	opportunity. We can't complain about government
16	that doesn't work, and then we have an opportunity
17	to make it work, to fix it. All of us together.
18	On your sacred honor, give us that opportunity,
19	please. Thank you for your time. Thank you for
20	listening to us.
21	BOARD MEMBER ROATE: Sir? The gentleman
22	with his hand up.
23	MR. KAPITAN: Yes. My name is a Steven
24	Kapitan.

1	BOARD MEMBER CONSTANTINO: Spell that.
2	
	MR. KAPITAN: Steven, S-t-e-v-e-n,
3	K-a-p-i-t-a-n, and I have a couple of questions.
4	One specifically, I am not understanding the
5	\$750,000 and the \$8 million mortgage. Who is
6	going to be paying that mortgage? If the County
7	is getting the cash
8	BOARD MEMBER CONSTANTINO: The new owners.
9	MR. KAPITAN: The new owners? Okay. So,
10	they are paying the County gets the
11	\$8.3 million, and the new owners pay them how
12	much?
13	BOARD MEMBER CONSTANTINO: They pay them
14	\$8.3 million.
15	UNIDENTIFIED SPEAKER: Monthly payments?
16	BOARD MEMBER ROATE: I don't know how the
17	payments are set up.
18	MR. KAPITAN: But I thought you said that
19	the cash so, they pay them
20	BOARD MEMBER CONSTANTINO: That's how this
21	project is funded, is \$750,000 in cash, and a
22	mortgage for the remainder. The purchase price is
23	\$8.3 million.
24	MR. KAPITAN: Does this county have an

1	outstanding mortgage on this?
2	BOARD MEMBER CONSTANTINO: I couldn't tell
3	you. I don't know. All we are looking at is the
4	change of ownership.
5	MR. KAPITAN: The transaction. Okay. I
6	see. So, what is the mortgage? So, they are
7	paying installments for basically, they are
8	paying installments for the rest of the
9	\$8.3 million?
10	BOARD MEMBER KNIERY: They get financing.
11	It's outlined in the application. The transaction
12	is for the full amount. It has been cited how the
13	applicant, the new owner, is proposing to buy the
14	property. That total amount, though, goes to the
15	County.
16	MR. KAPITAN: Is that the \$8.3 million its
17	present value?
18	BOARD MEMBER KNIERY: No. That's the
19	dollar amount of the transaction.
20	MR. KAPITAN: Yeah, but they are not
21	getting it in cash up front. If they are getting
22	it
23	BOARD MEMBER KNIERY: So, that's
24	MR. GREGORY: Sir, may I just? So, if you

1	were buying a home, you would put X dollars down.
2	That's the \$750,000. The County is selling the
3	home. So, the County would get the full \$8
4	million. They put their money down, and then they
5	will get a mortgage independent of the County that
6	they will have to pay with their private borrower.
7	MR. KAPITAN: Okay. So, the company is
8	borrowing the \$8.3 million?
9	BOARD MEMBER KNIERY: Excuse me, sir. So,
10	can you give the court reporter your name?
11	MR. GREGORY: Bryan Gregory.
12	BOARD MEMBER KNIERY: Thank you.
13	MR. KAPITAN: That clarifies it. Thank
14	you very much.
15	My other question, then, is could you
16	outline the criteria by which this Board makes
17	this decision, summarizing it, and then give us a
18	website direction where we could find more
19	specifically in more detail what that criteria is.
20	BOARD MEMBER CONSTANTINO: I could first
21	give you the website address for our Health
22	Facilities and Services Review Board. That is
23	www.ihfsrb, India, hotel, foxtrot, sierra, Romeo,
24	bravo, dot @Illinois.gov.

1	MR. KAPITAN: Can you give us today a
2	brief summary of what that criteria is?
3	BOARD MEMBER ROATE: The criteria is set
4	criteria to determine applicant financial
5	liability, to determine the viability of the
6	transaction, and this is the information that gets
7	presented to Board staff in their applications.
8	The Board staff then assembles a report and
9	presents it to Board members, and the Board
10	members will make the decision at the July 27th
11	board meeting.
12	MR. KAPITAN: And where does the testimony
13	here today fit into that.
14	BOARD MEMBER ROATE: The testimony fits
15	into public comment, which is presented to each
16	Board member well before the board meeting.
17	Everything that is said and everything that is
18	documented today will be delivered to the Board
19	members in sufficient time for them for each of
20	them to review ahead of this board meeting.
21	MR. KAPITAN: Thank you.
22	BOARD MEMBER ROATE: Thank you.
23	Sir?
24	MR. OSTROM: I'm not done. Mike Ostrom,

24	looking at their record or their the way they
