The State Agency Report and related materials for this project will be posted on the State Board website 14 days before the State Board meeting.

Project #23-036, NANI Vascular North ASC, Addison. Applicants: NANI Vascular North ASC, LLC, and Nephrology Associates of Northern Illinois, LTD. The applicants propose to establish a single -specialty ASTC providing vascular access procedures. The facility will be located at 2055 Army Trail Road, Addison. Project cost: \$5,206,120.
