Pursuant to 77 Illinois Administrative Code Section 1130.730 we are submitting this request to extend the financial commitment period for Project #23-040. The permit was approved on March 12, 2024.

The Illinois Health Facilities and Services Review Board approved this project to establish an Ambulatory Surgery Treatment Center performing cardiovascular catheterization services at 10 Martin Avenue in Naperville, Illinois. This project is moving forward and the development of the ASTC is progressing without delay; however, we are still finalizing the execution of the real estate lease for the suite. The formal execution of the lease should be completed in the next few weeks. Relative to progress on the project, construction is complete and the paperwork for construction review was submitted to IDPH in mid-February. We expect the IDPH architects to survey the building within the next month. The execution of the lease is imminent.

Endeavor Health (previously NS-EEH Holding d/b/a NorthShore-Edward Elmhurst Health) hereby requests a 1-year extension of the financial commitment period for Project #23-040, consistent with the requirements of Administrative Code 1130.730. Enclosed is a check in the amount of \$1,000 for the \$500 application processing and the \$500 fee for notification being submitted less than 45 days prior to the financial commitment date.

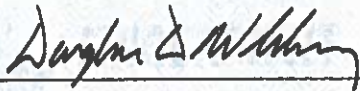
