# Re: Innovia Surgery Center (Proj. No. 23-046)

Dear Mr. Kniery:

This office represents Innovia Surgery Center ("Innovia"). In this capacity, we are submitting additional information responsive to the Health Facilities and Services Review Board ("HFSRB") members' questions at the March 12, 2024, HFSRB meeting.

As discussed at the March 12, 2024, HFSRB meeting, treating underserved patients is a core to who Innovia is, and the application to add spine and orthopedics cases is an extension of that philosophy. Historically, Innovia provides a significant amount of Medicaid and charity care compared to other ambulatory surgery center centers in Illinois.<sup>1</sup> With the addition of spine and orthopedics, Innovia anticipates expanding access to surgical services to more underserved patients. Dr. Erickson and Dr. Park approached Innovia several months ago because, as independent physicians, they could not schedule their Medicaid, workers' compensation, and personal injury cases at nearby hospitals. For many of these patients, Innovia is their only option. Approving Innovia for these surgical services will allow Dr. Erickson and Dr. Park to treat their patients more efficiently and allow their patients to return to work or resume their normal activities more quickly without adversely affecting local hospitals.

#### 1. Treatment Room Need Assessment

This review criterion requires an applicant to demonstrate the number of operating/procedure rooms are needed based on an annual minimum utilization of 1,500 surgical hours per operating/procedure room. Innovia has two operating rooms. To justify the need for the second operating room, Innovia must perform over 1,500 hours of surgery annually. As documented in the attached letters, the following physicians anticipate performing cases at Innovia in 2024. Based on the anticipated surgical procedures, Innovia will have sufficient volume to justify its two operating rooms.

As evident in the enclosed support letters, there is a lot of enthusiasm from the physicians to bring their patients to Innovia. Innovia will continue to bolster its marketing efforts to bring even more physicians on board. Innovia also looks to partner with a nationwide management company that can assist it in reaching out to more physicians.



#### 2. Projected Payor Mix

The projected payor mix for the physicians performing at Innovia is provided in the table below.

All the referring physicians listed in the table above accept Medicaid patients from the range of 5-89%.

With respect to the addition of orthopedics and spine cases, Innovia will not adversely affect nearby hospitals. Dr Erickson and Dr. Park are independent practitioners who want to perform cases that nearby hospitals will not accept such as Medicaid, workman's compensation, and personal injury cases. *Importantly, no hospital objected to the addition of orthopedics and spine procedures at Innovia.* 

Many of the patients Dr. Erickson and Dr. Park intend to bring are Medicaid, Workers' Compensation and Personal Injury patients who often do not have transportation or speak English to receive the care they need. It takes a concerted effort on Innovia's behalf to arrange access to their scheduled surgery. These patients often need several visits to Innovia; they may start out with diagnostic procedures, then pain injections and then eventually progress to surgery.

Familiarity with the facility and the medical team can help alleviate some of the stress and anxiety associated with surgery, particularly for those already dealing with pain and discomfort. Obtaining the HFSRB's approval for these procedures would be a pivotal step for these vulnerable patients that need assistance in scheduling several visits.



#### 3. Scheduling Surgical Procedures

Innovia has two operating rooms and has block time available Mondays through Fridays from 7 a.m. to 4 p.m. and Saturday from 7 a.m. to 2 p.m. (or 104 hours per week/5,408 hours annually). As shown in the table in Section 1, Innovia anticipates a total of 2,526 surgical hours in 2024. Accordingly, Innovia has sufficient capacity to accommodate current and future surgical cases. This would be a tentative schedule.

## 4. Interventional Radiology

Innovia's certificate of need permit for interventional radiology was approved in 2020 during the heart of the COVID-19 pandemic. Prior to that time, Dr. Chopra provided a referral letter for interventional radiology, and he was extremely excited to bring patients to Innovia. Then the world changed due to the COVID -19 pandemic. The unexpected challenges brought on by COVID affected Dr. Chopra's practice, which primarily serves elderly patients and those from nursing homes; these patients could not leave their homes or care facilities for elective procedures. During that time, Dr. Chopra ventured into new prospects where he started a new medical organization and opened a new office as well. He has also been out of the country working on various projects including charity work to help the disadvantaged.

Innovia met with Dr. Chopra recently and he is committed to return to Innovia. His group has brought new providers on board, and he intends to bring 6-8 cases per month in the next few months. He has already performed interventional radiology cases at Innovia.

From 2021, interventional radiology cases were performed at Innovia; however, they were not reported on the Annual Ambulatory Surgical Treatment Center Questionnaires because there is no category for "interventional radiology" or "other." Due to lack of category option, Innovia recorded those interventional radiology procedures as pain management. This information was communicated to HFSRB staff on May 8, 2024 to address questions regarding the status of interventional radiology procedures at Innovia.

#### 5. Physician Recruitment Plan

Innovia is continuously recruiting physicians to increase utilization at the surgery center. It employs a focused recruitment plan to attract skilled physicians who align with its mission and



values. Leveraging diverse channels and strategic partnerships, it optimizes its outreach efforts to connect with top talent in the medical community. Innovia's recruitment plan, described below, combines targeted strategies to attract top physician talent, ensuring ongoing success in meeting its staffing needs.

#### LinkedIn and Professional Platforms:

Utilizing LinkedIn, Crain's Chicago Business, and other professional platforms to highlight Innovia's capabilities will allow it to engage with potential candidates through targeted advertisements and sponsored content.

#### **Online Job Portals:**

To maximize visibility on job portals like Indeed and Gusto, Innovia optimizes postings and highlights competitive compensation packages and benefits.

#### Partnership with Management Companies:

Collaborating with a management company that is a nationally recognized leader in surgery center management will broaden Innovia's reach within the medical community, providing access to a wider pool of qualified candidates.

#### **Direct Mail Campaigns:**

Innovia initiates direct communication with physicians through personalized mailings to doctor's offices, creating memorable impressions and fostering relationships.

#### **Email Marketing:**

Segmented email lists and personalized messaging allow Innovia to engage with physicians directly, inviting them to events and demonstrating its commitment to their professional growth.

#### **Direct Outreach:**

Innovia's outreach plan focuses on identifying target specialties, personalized communication, and offering collaborative benefits. It actively visits local and nearby physician offices establishing relationships and providing education opportunities. By monitoring outcomes and engaging in community events, Innovia aims to build a strong network of committed physicians.



#### 6. Process Improvement Plan for Adding/Removing Surgical Specialties

Due to various factors, e.g., unexpected physician retirements and the COVID-19 pandemic, Innovia was underutilized. To improve capacity and performance at the surgery center, Innovia began various recruiting initiatives. As noted in a recent *Becker's ASC Article*, failure to add more specialized services, like spine and orthopedics in Innovia's case, can be a lost opportunity. Adding surgical specialties allow a surgery center to thrive by increasing "access to care for patients while giving nurses the ability to utilize their skills fully."<sup>2</sup>

Moreover, there are many areas of Urology and Gynecology which overlap with Interventional Radiology and for these reasons Innovia would like to keep all the specialties that it has been granted by the HFSRB. These specialties are very interrelated and as technology evolves, there will be more opportunities for collaboration between them.

## 7. Surgical Staff Credentials

A key to a robust and thriving surgery center is prioritization of both cost management in service management and excellence in staffing. Innovia understands compromises in staffing can have significant negative impacts on patient outcomes and reputation.<sup>3</sup> Innovia's ensures its staff of Registered Nurses and Scrub Techs are experienced in spine and orthopedics cases from working with these specialties in other surgery centers. Innovia also has various equipment vendors that train its staff in advance on new equipment, and they are also available on-site for procedures.

Dr. Erickson intends to perform **minimally invasive** spine procedures at Innovia. He has an experienced operating room spine team that he works with that will accompany him to Innovia. His team consists of a Physician's Assistant, First Assistant (who has worked with him for many years), an X-Ray tech, a Neuromonitoring Tech and a Scrub Tech specializing in spine procedures. They will be brought on as part-time staff after their credentialing is completed and certifications are verified.

#### 8. Dental Procedures

Innovia and Dr. Singhal are continuing to ramp up dental procedures at Innovia. From November 2023 to date today, Dr. Singhal has performed a total of 18 dental procedures at Innovia. Further, Dr. Singhal anticipates performing a total of 150 dental procedures at Innovia this year.

Dr. Shah has been recently credentialed at Innovia Surgery Center to perform medical/dental procedures. He intends to regularly schedule more patients as seen in Dr. Shah's referral letter. He is also looking forward to collaborating with ENT physicians since there is some overlap in treatment for his patients.

As noted throughout the application and in comments at the HFSRB meeting, Innovia is committed to serving underserved patients. HFSRB approval of spine and orthopedics will allow Innovia to expand access to patients who have no other viable options. I am writing to express my gratitude for the partnership between my dental practice and Innovia Surgery Center in facilitating general dentistry cases under general anesthesia. Since receiving approval for the Certificate of Need (CON), Innovia Surgery Center has been invaluable in ensuring that our Medicaid patients and patients with disabilities receive the unique comprehensive care they require.

My office has encountered some hurdles in scheduling these patients for procedures at the surgery center. One significant hurdle has been the requirement for patients to see a primary care physician on short notice, particularly those who are Medicaid recipients. Finding a primary care physician who can accommodate our patients' needs within a tight timeframe and accepts Medicaid has proven to be a challenge, sometimes resulting in delays in scheduling procedures.
