In accordance with the requirements of the Illinois Health Facilities Planning Act, notice is given of receipt to establish an Ambulatory Surgery Treatment Center (ASTC), in Alsip. Project #24-005, NANI Vascular South ASC, Alsip. Applicants: NANI Vascular South ASC LLC, Nephrology Associates of Northern Illinois, Ltd., NANI Vascular ASC, LLC, and Willow Springs Surgery Center, Ltd. The applicants propose to establish a single-specialty ASTC, providing vascular access surgical services. The facility will be located at 12250 South Cicero Avenue, Alsip. Project cost: \$5,813,534.
